Chair Tim Vincent called the meeting to order.

Staff and persons from the audience were sworn as to their testimony in the following matters for this meeting.

1. APPROVAL OF MINUTES FROM JULY 12, 2011 MEETING:

Mr. Burgess moved to approve the minutes from the July 12, 2011 meeting as written, seconded by Ms. Ata. The Commission voted unanimously 4-0 in favor of the motion.

New Cases:

2. 700 North English Street - (TMN 128-8-20/Parcel #0020006) – Irene Agapion Palamaris & George S. Palamaris, Owners – In the Matter of Order to Repair, Alter or Improve the Structure. Inspectors McDougal & Hovander. (REMOVED FOR SERVICE)

Inspector Hovander stated that this case has been removed due to service issues.

Continued Cases:

 312 Franklin Boulevard – (TMN 210-4-15) Joseph & Lisa Stutts, Owners – In the Matter of Order to Repair, Alter or Improve the Structure. Continued from the June 14, 2011 Housing Commission Meeting. Inspectors McDougal & Hovander. (CONTINUED UNTIL DECEMBER, 2011 MEETING)

Chair Vincent asked the owner for an update on progress being made on this property. Joseph Stutts, 303 Bessemer Avenue, stated that previous bank issues have been resolved. He has spoken with Captain Hall, Greensboro City Fire Department, who agreed to burn the house. There are approximately 80 houses waiting to be burned before the Franklin Boulevard property; therefore, Mr. Stutts indicated it will be October or November before action can be taken.

Inspector Jones stated that the house had been secured and did not pose a hazard. Inspector McDougal requested that the owner continue to check the property periodically to make sure it remains secure as this has been an issue in the past and there is a school located nearby. The owner agreed to make sure the property was kept secure.

Ms. At a moved to continue this case until the December, 2011 meeting, seconded by Mr. Burgess. The Commission voted unanimously 4-0 in favor of the motion.
