MINUTES OF THE ENTERTAINMENT FACILITY USE ORDINANCE REVIEW COMMITTEE  
OF THE  
CITY OF GREENSBORO, NORTH CAROLINA

29 NOVEMBER 2012

The Entertainment Facility Use Ordinance Review Committee of the City of Greensboro met at 10:30 a.m. on the above date in the City Council Chamber of the Melvin Municipal Office Building with the following members present: Councilmember and Chairman Zack Matheny, Councilmembers Marikay Abuzuaiter and Jim Kee; Deputy City Manager Jim Westmoreland, City Attorney Mujeeb Shah-Khan, Assistant Police Chief Dwight Crotts, Police Attorney Jim Clark, and City Clerk Elizabeth H. Richardson.

Councilmember Matheny opened the meeting at 10:35 a.m.; thanked everyone in attendance; reviewed the purpose of the committee; and asked for a motion to approve the minutes of the November 15, 2012 meeting.

Councilmember Abuzuaiter made a motion to adopt the minutes of the November 15, 2012 meeting. The motion was seconded by Councilmember Kee; and adopted by voice vote of the committee.

.....

Councilmember Matheny stated that the committee would allow speakers five minutes each; explained that staff would review the comments and questions to understand the concerns presented today; that the committee would receive and review the formal responses from staff; and set a meeting at the end of this meeting to reconvene in the next several weeks.

.....

Thurston Reeder, 119 North Chimney Rock Road, owner of Thirstys 2; explained that he had been in business for over twenty years; spoke to the nature of trouble in the business; stated he had not had to call the police except for burglar alarms and other non-criminal incidents; referenced persons on the list that had been in business for ten years or more; that he would not be able to afford to stay in business if the proposed ordinance was adopted; and voiced concern for the number of businesses that would be affected by the proposed ordinance. Mr. Reeder expressed concerns with the following venues being excluded from the list of service calls dated November 20<sup>th</sup>: Club Fifth Seasons, Greensboro Country Club, Starmount Country Club, Revolution Banquet Hall, Elks Club, and Odd Fellows Lodge; asked that this be addressed; and referenced the actual number of actual crimes that had taken place compared to service calls received.

City Attorney Shah-Khan advised that staff would get the answer regarding the exclusion of certain establishments named by Mr. Reeder.

Councilmember Matheny requested Mr. Reeder provide a copy of the list of the establishments excluded from the list which he had referenced to Deputy City Manager Westmoreland.

.....

Christopher Gregory, 3806 Arundel Court, co-owner of Lotus Lounge, stated his club had not had problems; referenced addressing those persons who broke the law; stated that some clubs did need to improve their security training; explained that club owners did not want a security staff that was insufficient; that security was important to club owners; and that clubs with a good track record should not be forced to spend money on something that was not needed.

Councilmember Kee inquired about the 121 calls made to Lotus Lounge.

Mr. Gregory verified that he or one of his staff had made some of the calls for assistance from police in removing disorderly patrons from the premises and the areas within the Lounge’s vicinity; explained that he did not stand for people not upholding the law; and had no problem calling the police for assistance as this helped with keeping problems out of the Lounge.

.....

Eric Robert, 816 South Elm Street, stated he was in the process of opening an art gallery and event space; that he understood the need for safety but that he felt this was an attempt by the Police Chief and Police Attorney to bypass the system and create laws rather than enforce them; stated he did not understand the selection process for who was on the list; asked why specific venues were not on the list; reiterated that the selection process was flawed and asked for an explanation of how venues were selected.

.....

Attorney Ken Keller, 235 North Edgeworth Street, stated he represented Greene Street Nightclub, expressed concern with the proposed ordinance requirement for clubs to use independent third party providers for security; referenced Act 74C3A6 which provided the definition of a security guard; stated he had contacted several private security providers in the area and that only one would agree to provide security personnel for the inside of a bar; and emphasized that proprietors would need to go outside for security to a limited number of providers of the service that the proposed amendment was mandating. Mr. Keller voiced concern that the proposed draft purported to the requirement that proprietors assume responsibility for incidents in parking lots which the proprietors had no legal authority over; with the lack enforcement standards; questioned what would trigger enforcement; the appeals process; and spoke to the lack of a remedy in Superior Court. Mr. Keller spoke to the number of calls that were itemized and list of calls that were actually attributed to premises at 113 Greene Street; stated that if service calls were the triggering event for enforcement calls, that the ordinance created unintended consequences; and stated that the incentive on keeping the peace was to call the police, which would not be the case with the proposed ordinance change if service calls were to be the triggering event.

Councilmember Matheny confirmed that video was available.

.....

Rocco Scarfone, 3017 High Point Road, spoke on behalf of a number of club and restaurant owners; provided a PowerPoint Presentation which outlined the number of calls since 2010; explained that calls for medical assistance generated two and three distinct and separate calls for each incident in accordance with Guilford Metro 911; referenced the number of calls to locations that would not be subject to the proposed change; spoke to what the calls included; and explained that the ordinance was not written strictly for nightclubs. Mr. Scarfone voiced concern that establishments would be affected as a result of having live entertainment, karaoke, and live participation with an occupancy over 150 such as Village Tavern, Printworks Bistro and possibly Kickback Jacks; provided a quote from John W. Calicutt of Walton Investigations and Private Security; licensing issues for proprietors under Chapter 74C; referenced Charlotte’s ordinance; spoke to the recent shooting at the GYC Carnival at the Coliseum; and the shooting at the Theatre at Four Seasons in 2009. Mr. Scarfone made reference to Police Attorney Clark’s memo dated November 15, 2012 to the Committee; and added that the ordinance would circumvent North Carolina General Statute 19 which allowed any municipality to pursue legal remedies to close troubled establishments while giving the owner of the establishment due process.

Deputy City Manager Westmoreland requested staff be provided with the speakers comments and presentations.

.....

Amiel Rossabi, 109 Kemp Road East, explained that he represented restaurants, clubs and other entertainment facilities; that he had been involved in the process for several years; voiced concern that the process necessitated everyone to figure out a common ground which would keep patrons safe; allow business owners to operate, and do what was constitutionally protected in that regard. Mr. Rossabi spoke to the good things that were happening by explaining that many businesses hired off-duty police officers; had security plans; and met with the Police Department on a quarterly basis to discuss the issues and to avoid regulations that would create problems; voiced concern for knee jerk reactions which were not limited; stated that the proposed way of handling things had changed; and asked why the City had gotten away from the Mecklenburg ordinance where the ALE was already involved. Mr. Rossabi voiced concern with selective enforcement of the proposed ordinance which would give unfettered discretion; provided a video which showed fifteen officers going into a Downtown club to check if the paperwork for the security personnel was on file on June 17, 2011; spoke to the affect on businesses as a result of this process with the present legislation on the books; stated he had worked to successfully close down the massage parlors in the area; and stated he would continue to work with staff in this process.

Katie Cranford, 2605 Dellwood Drive, voiced support of what had been said already; spoke to the number of calls and incidents; voiced concern with ordinances that suppressed specific venues, groups, and mid-level and lower end entertainment venues; referenced the difference between strip clubs and night clubs; shootings that had taken place in shopping centers and malls; and voiced concern for Council support of spending \$40 million on high end entertainment. Ms. Cranford expressed concern with the public perception that Downtown was unsafe; stated that patrons wanted to be in safe environments; bad things could happen anywhere; referenced the shootings that had taken place in nightclubs during the past two years; stated she wanted to be proud of what Greensboro was doing and building; and asked Council to take these concerns into consideration.

.....

Doug Atkins, 4319 Ravenstone Drive, spoke to being a longtime resident and operator of various businesses from restaurants to adult oriented businesses; stated that he had not had a shooting at one of his businesses; asked if inside club security would have prevented any of the violent acts reported in the last five years as the incidents took place outside; added that several of his businesses had security 24 hours a day; that no ordinance would change human behavior; and that he did not feel the ordinance would be advantageous to or enhance public safety. Mr. Atkins continued by stating that all business owners wanted safe venues for patrons; that the ordinance as written was a business destroyer; that he and a group of business owners had been meeting on a quarterly basis with the Police Department to discuss public safety; voiced concerns for the number of calls related to apartment complexes; and requested that all parties sit down to develop a solution that would work for everyone.

Councilmember Kee requested that a report of service calls to apartment complexes be provided to the committee members.

.....

Lance Jones, Sr., 4925 West Market Street, spoke to his security experience; containment of an incident; proper equipment and license requirements for security guards; the need for a balance to enforce and regulate that bouncers were certified registered security; and importance to mitigate the chances of incidences by crowd control. Mr. Jones added that a portion of bouncers had criminal records which prohibited them from obtaining employment by security companies; that he understood the concerns of the business owners and the City; that there were local security companies who could manage crowd control adequately for a reasonable cost to the local establishments; and reiterated the importance in training both armed and unarmed guards as well as providing them with the necessary equipment to perform the job.

.....

Councilmember Matheny asked if anyone else wished to speak. There being no one, Councilmember Matheny asked the committee members for questions and comments.

Councilmember Abuzuaiter thanked the owners for attending; stated the information had been very informative and would assist the committee going forward; and stated she had several questions for staff, the first being if a break down could be provided as to whether or not a club employee had initiated a service call or if the call came from outside of the venue.

Susan Danielson with the Police Department confirmed that the department could determine whether a call came from law enforcement and non-law enforcement but that it would be difficult to determine when a call had come from a mobile phone as it could not confirm the caller was calling from the club address.

Councilmember Abuzuaiter explained that staff could get back to the committee if the answer was not available today; and requested the breakdown the calls for service between what was gauged as a serious and non-serious crime at nightclubs; stated crime was down over the past three years; and spoke to what the committee would need to look at as it related to the ordinance.

Police Attorney Jim Clark explained that staff would clarify the general crime and public safety related service calls; and segregate out calls for service that were not crime related.

Assistant Police Chief Dwight Crotts explained the process for department when analyzing the service calls that came in to determine what type of call it was.

Councilmember Kee echoed that the meeting had been very informative; voiced that the intent of everyone was to increase public safety; stated that the committee was not targeting particular businesses; expressed the importance in looking at and comparing service calls in other industries and businesses to nightclubs; stated he was interested in knowing how the department derived a threshold for exclusion of specific businesses; spoke to the need to get answers to determine if an ordinance amendment was needed; and thanked the owners for participation in the meeting.

Councilmember Matheny explained that a follow up meeting would need to be scheduled to allow staff the opportunity to provide answers to concerns and questions for discussion by the committee; asked the speakers to forward their information and presentations to Deputy City Manager Westmoreland; referenced the length of time the City and owners had been in discussions about public safety in private meetings; importance in having open meetings to allow public the opportunity to provide their input and work together for a solution; and made a comparison of this and the noise ordinance process. Councilmember Matheny made reference to prior instances of knee jerk reactions to an incident to legislate issues which needed to be avoided in the future; reiterated that the committee was not trying to stop human behavior but create public safety which would be inclusive of the diverse population and growing area; the need to create a balance of police resources for the entire city rather than focus on certain areas; and stated he appreciated those involved in the conversations today and over the past two to three years.

Councilmember Kee requested that the statistics for service calls to other businesses be in the same format as the service calls on the report for nightclubs.

.....

It was the consensus of the committee to meet on Thursday, December 13, 2012 at 10:30 a.m. in the Council Chamber to hear from staff and have an open discussion regarding the information provided; and confirmed that a vote would not be taken on the proposed ordinance at that time.

Police Attorney Clark confirmed that answers could be provided by that date.

The meeting was adjourned at 11:44 p.m.

**Responses to Questions Posed Through the City Council**  
**Entertainment Facility Use Ordinance Committee**

**Businesses affected by the ordinance**

1. Why did some businesses that were shown in an October 9<sup>th</sup> list of businesses that would be affected by the ordinance document, drop off the final list of businesses affected by the ordinance? (Examples given were Elk's Lodge, Starmount Country Club, Fifth Seasons, Greensboro Country Club and others)

***After the first draft of the EFUO, City Staff from Police, Fire, Legal and Planning departments reviewed available information to determine what types of businesses would be affected by the EFUO. As the review progressed, it was noticed that the definitions in both the LDO and EFUO would leave out certain entertainment facilities that should be included, and it included businesses that have different characteristics from live entertainment facilities and lacked the crime problems or risks the EFUO is intended to curb.***

***The Elks Lodge and Country Clubs, as examples, have organizational structures and membership or admission requirements that differentiate them from public club facilities. The Fifth Seasons also differs from a typical nightclub in that it is an accessory use to the hotel.***

***City Staff revised the ordinance to include or exclude these businesses during the review process as the limitations in the draft ordinance became apparent.***

2. What was the selection process used for the City to place a business on the list affected by the ordinance?

***The Land Development Ordinance (LDO) defines categories and specific types of land uses, and the EFUO is drafted to affect businesses which fit into the categories. The list of 58 businesses is the City's good faith effort to identify establishments that would be affected by the draft ordinance, if it went into effect.***

***This list is based upon the most accurate data available at the time of publication. Due to the changing nature of some of these establishments and limitations of existing databases, the list may not be all inclusive and/or may contain inaccuracies.***

3. Why are some businesses exempt from the ordinance and not others?

***The definitions in the LDO, and additional conditions in the EFUO, are intended to limit the effect of the ordinance on the fewest number of businesses possible and only on a narrow group of uses where the crime problems and significant risks exist. Three categories of nightclub-type businesses emerged:***

- **Entertainment facilities with an occupancy capacity of 150 or more operating after 9 pm, at which alcohol is sold, served or consumed, and which includes dancing or live entertainment**
- **Sexually oriented entertainment businesses after 9 pm regardless of occupancy level**
- **Facilities at which dancing or live entertainment is conducted after 9 pm for persons under 21 years of age, regardless of alcohol being sold, with an occupancy capacity of 150 persons or more**

**Entertainment Facilities shall not include taverns, bars, lounges, cocktail lounges and other drinking establishments where electronically reproduced music emanating from a loudspeaker system is provided for the listening pleasure of patrons, so long as no other public entertainment is provided or allowed.**

4. Why is the City considering an ordinance that affects all clubs when only a few cause problems?

**Constitutional law protects businesses by preventing local governments from regulating a single or specific establishment. Additionally, the City has limited power under State law to take action against individuals or specific businesses where significant crime problems occur. The combination of these two factors, and the need to increase patron safety, resulted in the existing draft ordinance. The City knows that some establishments with a better track record of patron safety will also be affected by the EFUO. Both City and club representatives agree that they want safe establishments. The purpose of this ordinance is to increase the likelihood that clubs are safe. Its focus is on crime prevention, rather than law enforcement.**

5. Why does the ordinance as written affect businesses with sporadic live music, such as Print Works Bistro, Kickback Jack's, Village Tavern, etc.?

**Actually, the current draft of the EFUO would not affect these businesses. Restaurant-type principal land uses are not included in the types of land uses subject to the ordinance.**

6. Why did City Staff exclude certain types of facilities from the proposed ordinance?

**See the answers to Questions 1-5, above.**

7. How did City Staff decide to use a minimum occupancy level of 150?

**In 2011, City staff was directed by Council to find a way to reduce crime at nightclub establishments. The first draft ordinance contained an inclusionary provision of 100-person occupancy. In our first ordinance review meeting with a sample of club owners/managers, they strongly objected to the 100 occupancy threshold and the discussion yielded our raising the occupancy level to 150. The inclusion of sexually-oriented businesses, regardless of occupancy level, was added in summer 2012, when discussions among staff revealed that a**

***number of such clubs, where crime problems exist and risks are substantial, would not be governed by the ordinance.***

8. How was the minimum occupancy level of 150 in the ordinance chosen, and why is it fair to regulate only clubs that exceed 150 capacity?

***See the answer to Question 7, above.***

Legal issues

9. How is the ordinance Constitutional or fair, when enforcement standards are unclear and the City can enforce the ordinance before the club owner has appealed the City's decision?

***This proposed ordinance is intended to become a part of the LDO, which already contains enforcement standards and appeal processes. This ordinance is further governed by North Carolina law. General Statute section 160A-388 requires the City to hold action to enforce the ordinance until the completion of appeal processes in all cases except situations where a strong likelihood of irreparable harm exists.***

10. Doesn't the ordinance give the City unfettered discretion and permit selective enforcement?

***No. The City's discretion is already limited under both the LDO and State law applicable to zoning. The processes for enforcement of the proposed ordinance already exist under the LDO and have been long established and upheld under State and United States Constitutional law.***

***This draft of the ordinance constitutes a significant shift in the City's approach to address crime problems and risks at entertainment facilities, and is a direct result of multiple conversations with representative club owners and their attorney. In those conversations, there was complete objection to the police chief having the power to enforce and revoke entertainment licenses, and a concern that the appeal procedure to the City Manager would result in rubber-stamping the police chief's decision in an enforcement action. Additionally, club owners and their attorney objected to the early draft's creation of a new licensing process, when the privilege license process already existed. As a result of this conversation and to be sensitive to this concern, the City explored the use of the LDO and existing privilege licensing system, as both are established processes and neither places any power of adjudication in the position of the police chief or city manager.***

11. Why shouldn't the City just use authority under Chapter 19 of the General Statutes to address problem clubs, rather than enacting a separate ordinance?

***Nuisance abatement procedures (a/k/a Chapter 19 of the North Carolina General Statutes) do provide a mechanism to curtail businesses or activities that create public nuisances such as crime, drug dealing or other publicly harmful effects. Both the statutes and case law***



**concerning nuisance abatement recognize that such a powerful remedy should be limited only to nuisances which are of such a frequent and repetitive nature that the harm can only be stopped by closing the business. Such a remedy is rarely granted by the Courts.**

**The level and nature of crime at live entertainment facilities is significant and episodic, but often is not continuous. Therefore, these unsafe venues may not meet the threshold for nuisance abatement action.**

**Live entertainment facilities present additional enforcement challenges. The legal structure and existence of these kinds of businesses permit owners and operators to quickly close their businesses, reorganize as a different entity and re-open, without taking measures to address unsafe conditions.**

**Because business closure is particularly difficult, lengthy, and costly in this industry, and because the interests of the citizens and business owners are better served by avoiding business closure if at all possible, City Staff considered the most prudent course of action to promote public safety would be to require increased security provisions in order to reduce crime.**

12. Under General Statutes Chapter 74C, it is impossible for club guards to be licensed.

**There are no provisions in Chapter 74C of the North Carolina General Statutes that prohibits or prevents club security from being licensed, and there are no provisions which prohibit or prevent live entertainment businesses from using licensed security personnel.**

13. This ordinance is only a pretext to circumvent state laws and due process, and the City should use or live with enforcement under laws that are already available.

**The purpose of this ordinance is to improve safety and security at live entertainment facilities such as nightclubs and sexually oriented businesses. State statutes (such as General Statute section 160A-388) establish procedures with which the City must comply, and these procedures ensure that businesses receive full due process under law.**

14. The City should instead follow Charlotte's ordinance that exempts enforcement for facilities permitted by the NC ABC Commission.

**The ordinance currently used by Charlotte does not have the emphasis on improving patron safety that Greensboro desires. Charlotte's ordinance is drafted with the intent to provide an enforcement mechanism. The EFUO creates necessary additional safety measures at live entertainment businesses. The EFUO has no independent enforcement mechanism; the only enforcement provisions which exist for the EFUO already exist in the LDO and State law.**

15. The ordinance is not Constitutional because it does not comport with due process or equal protection.

***Please refer to the answers in items #9, 10, 11 and 13.***

16. Unsafe establishments should be closed using existing due process.

***We agree. The EFUO uses existing and long-established enforcement processes in the LDO and under State law. That EFUO does not establish any new enforcement processes or mechanisms. It only creates an additional requirement of security at live entertainment businesses for safety purposes, and its intention is to prevent crime and harm to people for a safer night-time entertainment environment in Greensboro.***

**Ordinance enforcement**

17. How can the ordinance hold club owners responsible for activity in parking lots where they have no authority?

***We agree that this provision in the Security manual needs to be revised. As written, it does require the club security to secure areas out to 150 feet away from their premises. For some clubs, that may simply cover their parking lot. For others, 150 feet away from the premises is well past their property boundaries.***

***We will amend item II. A. 7. of the security manual as follows:***

***“At closing time, the security personnel shall be responsible for clearing the patrons of the entertainment facility from the premises including parking areas which are under the control of the entertainment facility. Until such time as all patrons have departed any sidewalk and street areas in front of the premises and from other areas accessible to persons around the perimeter of the premises and within one hundred and fifty feet of the premises, security personnel will monitor patrons for unlawful conduct and promptly contact the police department in any circumstance where unlawful conduct appears to be taking place.”***

18. Does the ordinance as currently written require nightclubs to hire security from third-party companies?

***No.***

19. Why does the ordinance lack standards for how the ordinance will be applied?

***The EFUO is written to be part of the zoning code –the LDO, which already contains all necessary enforcement provisions.***

20. What triggers enforcement of the ordinance?

***A violation of the ordinance results in enforcement activities allowed under the LDO.***

***Violations include, but are not limited to:***

- ***Inadequate security staff for the number of patrons***
- ***Failure to abide by the facility security plan***
- ***Uncertified security staff***

***Calls for service***

21. What are the actual numbers of crimes occurring at clubs versus the calls for service numbers?

***We have provided data about calls for service and crimes in two spreadsheet books. The book entitled “Clubs Calls for Service and Offenses 24 hr” depicts the number of calls for police service to each establishment for years 2010, 2011, and 2012 in column C. Not all calls for service result in a criminal report. The actual number of crimes for each of the three years, by year, is shown in columns D-J. Columns K-N reflects the number of calls for service for the listed offenses.***

***The book entitled “Clubs Calls for Service and Offenses 9to6” depicts the actual number of depicts the number of calls for police service to each establishment between the hours of 9 pm and 6 am for years 2010, 2011, and 2012 in column C. Not all calls for service result in a criminal report. The actual number of crimes that occurred between the hours of 9 pm and 6 am for each of the three years, by year, in columns D-J. Columns K-N reflects the number of calls for service for the listed offenses.***

***Most – but not all – crimes also generate a call for service to the location where the crime occurred. Some crimes, however, are reported or discovered at a location other than where they occurred. In these instances, there would not be a CFS to the location of the crime, but rather to where the report was obtained. As an example: A person is shot a club, but no one at or from the club calls police about the shooting. The victim goes to a hospital for treatment. Hospital staff calls police. Police respond to the hospital, interview the victim, and learn the shooting occurred at the club. The CFS is assigned to the hospital, even though the crime occurred at the club.***

22. Do the calls for service numbers include calls made off-premises? If so, how did City Staff determine that these calls should be included?-

***CFS are assigned “to” an address. They reflect the number of times police were dispatched to a location or when police were simply present and needed to take action of some type. To determine whether or not calls to an address where made from that address would require each call to be individually reviewed. Even this degree of scrutiny could not conclude with certainty where the call originated – the prevalence of cellular phones makes that impossible.***

23. Doesn't the statistical information on calls for service include multiple calls for a single incident?

**No. The number of CFS (in all the reports) reflects only police response. CFS for Fire and EMS are not contained in these numbers. The numbers reflect single incidents: the data was screened and multiple calls for service for the same incident were purged. Calls initiated by police officers to these establishments were also removed from the count.**

24. Can City Staff tell whether a call for service came from the nightclub staff in a proactive response, as opposed to a patron call in reactive response? If so, please provide those statistics.

**We wish we were able to answer this question because we encourage people to call to prevent crime. To attempt to determine who called and for what reason would require each call to be individually reviewed. Even this degree of scrutiny could not conclude with certainty whether the call was made from a patron or club staff. An important distinction to make with respect to this ordinance draft is that there is no enforcement action that is predicated upon the volume of calls for service. This approach was a direct result of our early discussions with nightclub owners and their representing attorney, and their objections to any ordinance where City action would be predicated upon calls for service.**

25. Which calls for service in the list provided by City Staff are crime-related, and which calls are routine?

**See the answer to Questions #22 and 25.**

26. Which calls for service are used as a gauge by City Staff to determine whether a public safety issue exists at an entertainment facility?

**The City considers the totality of crime, nuisance and disturbance calls for service, and the impact on emergency resources when assessing whether or not an establishment poses a threat to public safety.**

27. Provide statistical information that shows the calls for service load of apartment complexes and compares them with entertainment facilities that would be affected by the ordinance. (Staff will produce a report of calls for service and crime for the 40 largest multifamily complexes in the City. A report for calendar year 2011 will provide data for both 24-hour and 9pm-6am periods. This can be compared to the 2011 data that is included in the 3-year data report for the 58 affected entertainment facilities.)

**We have provided the requested information in the spreadsheet book entitled "Multi-family Calls for Service and Crimes". It contains two spreadsheets with data for the year 2011. One spreadsheet shows all the calls for service and crimes throughout the year: the other only the calls for service and crimes from 9 pm to 6 am. However, we believe it is simply not relevant**

***to the discussion of whether we have a problem at entertainment facilities that needs to be addressed. We recognize that crime and disorder can be present in many types of establishments, and the City enjoys numerous proactive partnerships to reduce these unsafe conditions. The proposed EFSU is our proactive approach to reduce crime and disorder in clubs.***

28. Consider comparison statistics of calls for service with other businesses such as restaurants and/or the Coliseum.

***To complete this analysis on restaurants would require a substantial and unnecessary commitment of City resources, and any result would have no relevance as to whether we have a problem or significant risks at entertainment facilities governed by the ordinance.***

***The Greensboro Coliseum complex received 108 calls for service in 2011. Of those calls, 42 were between the hours of 9 pm and 6 am. These calls resulted in one case report for an assault that occurred between 9 pm and 6 am.***

#### *Policy issues*

29. The ordinance creates an unintended consequence, because the number of calls-for-service triggered this proposal. If calls for service trigger for this ordinance, then managers lose the incentive to call police to maintain safety.

***The volume of calls was one of the important points City Staff considered when drafting this ordinance. However, it is not correct to say that CFS “triggers” the ordinance. The only “trigger” for enforcement of the ordinance is a club’s failure to follow the code and its own security plan. One of the reasons for writing this ordinance is due to the fact that some club staffs have NOT called for service when a police response was clearly warranted. This ordinance creates conditions which will give club staff the skills and confidence to call for help when it is needed.***

***The need for increased safety at clubs triggered this ordinance. The volume of calls is one of several factors that support the principle of requiring owners/managers to take proactive steps to prevent crime and disorder. Owners always have been and always will be encouraged to call police to help maintain a safe environment. In part, this ordinance is necessary because some club staff have NOT called for service when a police response was clearly warranted.***

30. The problems this ordinance seeks to solve are really caused by sexually oriented businesses, and it is unfair to nightclubs to be included in this ordinance because the two types of business are very different.

***This assertion is false. An analysis of crime data from these businesses indicates that both types of entertainment facilities have similar problems and risks, and both types can benefit from the security provisions outlined in the ordinance.***

31. Would inside security have prevented any of the violence used as examples, when most acts occurred outside clubs?

***No one will know for certain if or how each of these incidents would have been affected by the presence of club security – that would be speculation.***

***We do know that well-trained, well-equipped security personnel can effectively manage crowds, and deter, detect, and react to unsafe acts before they get out of hand.***

***We also recognize that even the best security staff and the best security plan will not eliminate all criminal behavior. They can, however, mitigate unsafe conditions and create safer environments. To that end, this ordinance helps promote that environment and provides a baseline of sound security requirements and practices without being over-assertive. Nothing in this ordinance prevents a club owner/manager from exceeding security requirements or from working collaboratively with police and others to identify ways to improve patron and site safety and security. We welcome that level of commitment.***

32. Doesn't the ordinance hurt business by increasing costs?

***We believe that safe establishments attract and retain patrons—that's good for business.***

33. Clubs that lack a history of violence and/or do the right thing for public safety should not be subject to City regulations that require them to spend money where it isn't necessary.

***The EFUO was drafted by City Staff in the belief that it offered the most responsive compromises to previous concerns by nightclub owners while creating a reasonable set of regulations to improve public safety.***

***The City certainly wants to avoid creating regulations that create additional costs to citizens or businesses wherever possible. However, in some circumstances a regulation will carry additional costs. When this appears likely, it is the responsibility of City Staff to consider the purpose and effects of the proposed regulation and make a preliminary assessment of whether the public benefit outweighs the potential costs.***

***In the case of the EFUO, the potential benefits of increased crime prevention and reduced violence and nuisance calls at entertainment businesses are benefits that staff believes outweighs the costs which may be associated with improved club security.***

### Other concerns

34. Why is the City willing to suppress small- and mid-size entertainment businesses while it plans to spend millions to build a large entertainment business?

***The ordinance itself, as developed and presented, is designed to help improve safety in and around the affected businesses. It is clearly within the scope of the City's authority to seek pathways to prevent crime and promote public safety and order; and, there is clear evidence that entertainment facilities present a unique environment for crime and nuisance activities to occur without reasonable regulation. There is no connection, however, between the motivation for or development of this ordinance and any efforts to build a performing arts center.***

35. Why did GPD use 15 officers to inspect club paperwork on its license and security personnel?

***We understand the effect that officer presence can have on businesses. When planning enforcement actions and/or security operations, we estimate the number of officers needed based on several factors, including:***

- ***The mission***
- ***Officer safety***
- ***Patron safety***
- ***Public perception and trust***

***This is part art, part science. Usually, we achieve the right balance. The enforcement action that evening in June 2011, at Club Allure, posed some challenges:***

- ***The club had more patrons and security staff than usual due to SuperJamz***
- ***The facility has multiple stories***
- ***The operation required officials from multiple agencies***

***Officials wanted to be thorough, safe, and quick. The number of personnel dedicated to this effort was based on both the planning factors, and the special circumstances. The security check and review of the paperwork were performed thoroughly and quickly. Both officers and patrons remained safe. In this regard, we were successful. However, upon reviewing the video in 2011, we believe that while the actions were legal, the inspection of Allure did not require the number of personnel assigned to enter the facility to accomplish the task. We have reinforced the need for balance of presence and safety since this operation, and continue to reinforce it.***
