SUBJECT: Options on Funding Completion of Downtown Greenway

Background

Planning for the Downtown Greenway began in 2001 with the development of the Center City Plan. In 2007, the Greensboro Bicentennial Commission designated the Downtown Greenway as the signature project to commemorate the City's 200th birthday and in 2008, the citizens of Greensboro voted to support a street improvement Bond, which included \$7 million dedicated to the Downtown Greenway. The Downtown Greenway is a collaborative undertaking by the City of Greensboro and Action Greensboro, which will loop downtown with a unique 4-mile multi-use trail. The total cost for the entire Downtown Greenway is estimated at \$26 million.

Current Status

To date, the City has committed \$7.8 million in Federal, State and City bond funds towards this project and the private sector has committed \$8.4 million. Fifty percent of this project has been designed with seventy-five percent of the design to be completed by June 1, 2014. Additional funding of \$15 Million is required to complete the project. (Additional details on funding and project progress are in the attached memo dated June 20, 2013.)

Funding Options for Project Completion

To date \$122.7 million of the \$134 million 2008 Street Improvement Bonds have been allocated to street, sidewalk, streetscape and other transportation projects. This includes design costs for the projects below, with the construction of these projects to be funded from a combination of the remaining \$11.3 million in unallocated 2008 Street Improvement Bonds (available in 2018, if there are no cost overruns of transportation projects currently scheduled for construction.) and future authorized bond funds:

- Vandalia Road (Elm-Eugene St. to City limits) widening and sidewalks
- Church Street streetscape (downtown)
- Benjamin Pkwy/Bryan Boulevard (Holden Rd. to Wendover Ave.) widening

- Stanley Road (Hilltop Road to Koger Blvd.) widening and sidewalks
- Elm Street & Pisgah Church Road intersection improvements
- Lawndale & Pisgah Church Road intersection improvements
- Lewiston Road connector (Flemming Road to Lewiston Road)
- North Elm Street improvements (Cone Blvd. to Wendover Ave.)
- Various sidewalk projects.

Downtown Greenway funding options for the City include:

- 1) Assign a higher priority to complete the downtown greenway project over the other unallocated projects listed above. (Unallocated 2008 Street Improvement Bond funds would not be available until 2018 and would be dependent upon actual construction costs of transportation projects currently scheduled for construction)
- 2) Reallocate transportation bond funds from projects planned over the next 6 years:
 - a. High Point Road streetscape
 - b. Cone-Nealtown Road connector
 - c. Horsepen Creek Road improvements
 - d. Alamance Church Road improvements
 - e. Summit Avenue streetscapes
 - f. North Church Street improvements
 - g. Mackay Road improvements
- 3) Reallocate various other bond projects planned over the next 6 years including Street Improvement and/or P&R Improvements:
 - a. Barber Park-Phase 2
 - b. Hester Park improvements
 - c. Skateboard Park and Trail System expansion.
- 4) Future GO bond referendum for the Downtown Greenway (2016 or 2020).

Also to be considered is the current debt service funding challenge (due to historically low tax base growth and interest rates, resulting in fewer resources available to fund debt service than anticipated) that is projected to require additional annual resources equivalent to 1.0 cent on the tax rate over the next 4-5 years to fund the remaining \$150 million in GO Bonds to be issued between 2014 and 2018, when current bond authorizations expire.

SUBJECT: Downtown Greenway Update

Background:

Planning for the Downtown Greenway began in 2001 with the development of the Center City Plan. In 2007, the Greensboro Bicentennial Commission designated the Downtown Greenway as the signature project to commemorate the City's 200th birthday and in 2008, the citizens of Greensboro voted to support a street improvement Bond, which included \$7 million dedicated to the Downtown Greenway. The Downtown Greenway is a collaborative undertaking by the City of Greensboro and Action Greensboro, which will loop downtown with a unique 4-mile multiuse trail. The multi-use trail will be used by walkers, joggers, and bicyclists, for recreation and fitness, as well as, to travel around downtown. The Greenway also features many works of art and both natural and urban scenery, to be enjoyed by all who utilize the trail. By enhancing the urban landscape, it is also envisioned that the Downtown Greenway will generate economic development as investors look to locate close to this very attractive amenity. The total cost for the entire Downtown Greenway is estimated at \$26 million.

Phases:

The 4-mile downtown Greenway is being built in 4 phases and will pass through more than a dozen neighborhoods connecting with several other walking/multi-use trails. (See attached phasing map)

Phase 1: Phase 1 is split up into four sections and runs east west parallel to Lee Street:

- Section 1 (Five Points) runs from Freeman Mill Road to South Eugene Street
- Section 1A (Morehead Park) runs from Lee Street to Spring Garden Street
- Section 1B runs from Eugene Street to MLK Jr. Drive
- Section 1C runs from MLK Jr. Drive to Lee Street

Phase 2: Phase 2 features a rebuild of Murrow Boulevard and runs along a portion of Fisher Avenue, and is split up into five sections:

- Section 2A, 2B, 2C, 2D features a rebuild of Murrow Boulevard and runs north south, then east west from Lee Street to Greene Street at Fisher Avenue.
- Section 2E Will run east-west along Fisher Avenue from Greene Street to Eugene Street

Phase 3: Phase 3 will run along Eugene Street and Smith Street.

- Section 3A will run along Eugene Street from Fisher Avenue to Smith Street
- Section 3B will run along Smith Street from Eugene Street to Spring Street.
- Section 3C will run along Smith Street from Spring Street to Prescott Street

Phase 4: Phase 4 will run north south along the Norfolk Southern rail line from Smith Street to Spring Garden Street.

Construction:

- Phase 1 was the first section of the Downtown Greenway that was built which runs for ½ mile from Lee Street/Freeman Mill Road to South Eugene Street. Construction on the ¼ mile Section 1 was funded totally by Action Greensboro and was completed in 2010 for a total cost of about \$800,000.
- Phase 1A was the second section of the Downtown Greenway completed which runs ¼ mile from Lee Street to Spring Garden Street. Construction on Phase 1A was completed in 2012 for a total cost of \$1.1 million, which was funded by City of Greensboro Transportation bonds. Action Greensboro also contributed \$800,000 in artwork and landscaping for Phase 1A.
- Phase 3B was the third section of the Downtown Greenway that was built along Smith Street from Eugene Street to Spring Street and along Eugene Street from Smith Street to Battleground Avenue. This section of 3B was completed in 2013 at a total cost of \$790,000 and was funded by City of Greensboro Transportation Bonds.

Pending Construction:

- Phase 3A along Eugene Street from Fisher Avenue to Smith Street, Phase 3C along Smith Street from Spring Street to Prescott Street, and Phase 2E along Fisher Avenue from Eugene Street to Greene Street. The total estimated cost to construct these sections of the downtown greenway is \$3.5 million and is being funded with a Federal Grant of \$2.8 million with the city of Greensboro providing a match of \$600,000 and Action Greensboro providing \$100,000 to cover the matching portion of the Federal grant. Construction on this section of the Greenway is scheduled to start in the spring of 2014 and be complete by the spring of 2015.
- Design is underway for section 1B which runs from South Eugene Street to MLK Jr.
 Drive. Construction on this section of the Downtown Greenway will be funded by City of
 Greensboro Transportation Bonds.

Future Unfunded Construction:

- Phase 2A, 2B, 2C, 2D of the Downtown Greenway is currently under design and will feature a rebuild/reconfiguration of Murrow Boulevard from six lanes to four lanes. The total estimated cost for Phase 2A, 2B, 2C, 2D is \$10.5 Million. The 2008 Transportation Bond funds will not cover the cost to build this phase. An additional funding source will need to be identified to build Phase 2A, 2B, 2C, 2D.
- Phase 4 of the Downtown Greenway will run north south along the Norfolk Southern rail line from Spring Garden Street to Smith Street and possibly further north along the Norfolk Southern rail line to connect with the A&Y Greenway. The total estimated cost to build Phase 4 is \$5 million and it is estimated that it will cost an additional \$5 million to extend the greenway north to connect with the A&Y greenway.

Funding:

Public Funds:

Voter approved City Bond Funds = \$7,000,000

- The City has spent or encumbered \$2,565,319 in Bond funds towards design and construction.
- The City has designated an additional \$600,000 in Bond funds to match a Federal STP-DA grant to construct Phase 3A, a portion of 3B, and a portion of 2E.
- The City has issued \$835,371 in Bond funds to be used for construction of Phase 1B or for the design of Phase 4.
- Total City Bond Funds issued to date = \$4,000.690.

Federal Funding:

- The City secured a \$2,800,000 Federal STP-DA grant to fund construction of Phase 3A, a portion of 3B, and a portion of 2E.
- The City secured a \$487,000 Federal Earmark sponsored by Senator Kay Hagan and an additional \$206,000 in Federal STP-DA funds to fund the design of Phase 2A, 2B, 2C, 2D.
- \$163,550 in ARRA funds were spent on Phase 1A for solar lighting.
- \$50,000 in CDBG funds have been appropriated for the design of Phase 1B.
- \$94,956 in Metro Planning funds were used for project design expenses.
- Total Federal funds spent or available to date = \$3,801,506.

Total Public Funds spent or available to date = \$7,802,196.

Private Funds:

Private funds raised to date through various sources = \$8,416,705

Total private funds spent to date = \$3,738,502.

Private funds have been used to:

- design and construct Phase 1
- design Phase 1A
- provide artwork and enhanced landscaping for phase 1
- provide artwork, including the refurbished railroad underpass, and enhanced landscaping for phase 1A
- provide enhanced landscaping for phase 3B
- provide partial local match for Federal STP-DA grant to fund construction of Phase 3A, a portion of 3B, and a portion of 2E.
- provide local match for Federal STP-DA grant to fund design of Phase 2A,B,C,D.

SUBJECT: Options on Advancing Construction Start Date on Cone

Boulevard/Nealtown Road Project

Background

The Cone Boulevard/Nealtown Road Project is an extension of E. Cone Boulevard eastward and the extension of Nealtown Road northward across N. Buffalo Creek to connect with the extension of E. Cone Boulevard. The Cone Boulevard/Nealtown Road Project will provide improved access between the Nealtown Farms, Kings Forest, Woodbriar Estates, and Woodmere Park neighborhoods to/from the Shopping Centers located at Cone Boulevard & US 29 and the Greensboro Sportsplex located on 16'th Street. Construction of this project has been scheduled to begin Spring 2015 with completion expected Fall 2016.

Current Status

Design of this project has been completed. Right-of-way (ROW) property acquisition is under way and is expected to be completed within 60 days. Once the properties are acquired, the City will annex them in order for construction costs to be eligible for funding by Street Improvement Bond Funds authorized in 2008. The annexation process is expected to be completed no later than mid-February 2014.

The estimated cost of this project is \$10.9 million. Funding for Cone Boulevard/Nealtown Road has been spread between the two debt issues scheduled March 2014 (\$5.9 million) and March 2016 (\$5.0 million). This project funding schedule is in alignment with the construction schedule which has set the construction start date in the Spring of 2015 with completion Fall 2016.

Funding Options

To advance the construction start date of the Cone Boulevard/Nealtown Road Project from Spring 2015 to Summer 2014, an additional \$5.0 million would need to be included in the March 2014 debt issue to fund the entire project cost of \$10.9 million. This could be accomplished in one of the three following ways:

- 1) Fund project in 2014 by delaying \$5.0 million in other Street Improvement projects planned for the period March 2014 through February 2016, until March 2016. Projects to be considered for delay include Greenway funding, High Point Road Streetscape project, sidewalk improvements and street maintenance.
- 2) Fund project in 2014 by delaying \$5.0 million in various bond projects planned for the period March 2014 through February 2016, including Street Improvement and/or P&R Improvements, until March 2016. Projects to be considered for delay include Barber Park-Phase 2, Hester Park improvements, Skateboard Park and Trail System expansion.
- 3) Increase March 2014 debt issue by \$5.0 million, from \$45 million to \$50 million, and provide additional annual resources of \$500,000 to fund the related increase in debt service (equivalent of 0.2 cent tax rate).

Also to be considered is the current debt service funding challenge (due to historically low tax base growth and interest rates, resulting in fewer resources available to fund debt service than anticipated) that is projected to require additional annual resources equivalent to 1.0 cent on the tax rate over the next 4-5 years to fund the remaining \$150 million in GO Bonds to be issued between 2014 and 2018, when current bond authorizations expire.


SUBJECT: College Hill Neighborhood Plan Public Meetings Rescheduled

SUBJECT: Mobile Applications and Searchable PDFs

The Information Technology department is excited to announce four upcoming mobile applications that will enhance service delivery and engage the citizens in making Greensboro a great place to live, work and play. The mobile applications are as follows:

Customer Relationship Management (SeeClickFix)-Projected completion date: October 2013 This is an external/public facing application, which allows residents to enter service requests via their mobile device. This application is also integrated into our internal Contact Center application. This app will allow a citizen to report a pothole, graffiti, traffic signal not working, overgrown lot, etc. The citizen can take a picture of the problem and attach it to the work request. The work request will be routed to the City's Contact Center for further follow-up and then assigned to a work crew to complete. The person making the request, along with the general-public, will have the option to check the status of a request and make comments.

Bulk Waste - Projected completion date: October 2013

This mobile application will support changes in the collection practices for bulk and similar items. Through this application, each residential refuse collection truck will be equipped with a tablet computer that allows the driver to mark the location where a resident has placed a bulk (or similar) item out for collection. The following day, a bulk collection crew, also equipped with a tablet computer showing where bulk items have been placed out, will perform the collection. This project will enable staff to be as efficient and effective as possible by running predefined routes that have been determined by using the mobile application.

Find it - Projected completion date: Early 2014

This application will allow a citizen to input an address or use the GPS location of the mobile device to find the nearest City facility (park, recreation center, library, etc). The app will also tell you your council district and councilperson, confirm your property's zoning, and allow for query of colletion/removal days for solid waste, snow, and leaves.

Hike It - Projected completion date: Spring 2014

This application allows you to locate hiking and biking trails throughout the city. Citizens can track their progress, get directions and learn of amenities along the trails. The app will also have a social networking component allowing friends to coordinate hiking and biking excursions.

Searchable PDFs - Completed: August 2013

In an effort to provide transparency and open access to public records, the Information Technology department has completed a project to convert all PDF documents on the external website to searchable PDF documents. This was a lengthy and tedious process, which resulted in thousands of documents being converted so the public can search on a keyword and find the corresponding document on the website.

How many people does it take to process an electronic payment?
