We received a total of 5 comments this week:

Field Operations - 4 comments:

- The loose leaf collection crew that serviced my neighborhood on 12/30/13 did a great job.
 They were efficient, conscientious about cleaning up and vacuuming the leaves, and professional. Thanks for providing this service. I appreciate it.
- I was informed that the new supervisor for leaf collection decided to change the leaf pickup route. For this service to truly work requires that residents of Greensboro have some way to determine when leaf pickup will occur on their street. In the past, this could be accomplished by looking at the interactive map on your site. If the routes the leaf pickup trucks take continues to be a random or otherwise indiscernible process, leaves will have to be piled along the street for unnecessarily long periods of time which causes them to be blown around, kills the grass they are stored on, and will cause problems by clogging storm drains. The new random method of leaf pickup may appear as an improvement but only if the city wants to spend taxpayer dollars having trucks driving around and picking nothing up. Any assessment of this new method should account for the volume of leaves collected/collection costs.
- I had not been keeping up with leaf collection dates and noticed the crew on my street this morning. As they worked the other side of the road, I quickly ran out to see if I could get some of my leaves to the road before they returned. I only got through ½ of my lawn by the time they got to my curb. I was satisfied that I was able to get what I did done. To my surprise, they not only gave me a few more minutes to get more leaves to the curb, they also helped me rake. Both sweepers and the driver helped! They didn't have to do what they did but they did! The three guys are a big part of why Greensboro is a great place to live. Thank you.
- Really appreciated the collectors coming in the bad weather today and doing such a
 great job picking up the leaves.

Police – 1 comment:

 Complimented great officer that assisted her last night. Officer made sure she had everything she needed including her phone service. Very appreciative.

Calls about employment increased last week while calls about loose leaf collection remained steady. Call volume was busy for the week.
