AMENDING CHAPTER 30

AN ORDINANCE AMENDING THE GREENSBORO CODE OF ORDINANCES WITH RESPECT TO ZONING, PLANNING AND DEVELOPMENT

Section 1. That Section 30-3-3.4(A), Review and Recommendation, is hereby amended by adding a new Subsection (8) to read as follows:

- 8) Department of Housing and Urban Development Consolidated Plan
 - a) To review and provide recommendations concerning programs contained in the Consolidated Plan covering the Community Development Block Grant, HOME and Emergency Shelter Grant Program for the city;
 - b) To provide professional expertise for developing program goals and policy; and
 - c) To gather information from the public, development and business communities with respect to the Consolidated Plan.

Section 2. All ordinances in conflict with the provisions of this ordinance are repealed to the extent of such conflict.

Section 3. This ordinance shall become effective on July 1, 2012.

RESOLUTION TRANSFERING THE RESPONSIBILITIES OF THE COMMUNITY RESOURCE BOARD TO THE PLANNING BOARD

WHEREAS, The Housing and Community Department Act of 1987 reinstituted the requirement that each recipient of Community Development Block Grant funds adopt and follow a plan for allowing citizen participation in the application development process; and

WHEREAS, The Department of Housing and Urban Development adopted rules in requiring the submission of a consolidated plan covering the Community Development Block Grant Program, HOME Investment Partnership and Emergency Shelter Grant Program; and

WHEREAS, on February 2, 1995, the City Council directed the Planning Board to establish an Interim Community Resource Board and the Community Development Committee as sub-committees to receive input and make recommendations to the Planning Board and City Council concerning programs contained in the Consolidated Plan; and

WHEREAS, on November 20, 1995, the City Council directed the Planning Board to abolish the Interim Community Resource Board and the Community Development Committee as sub-committees and appointed a permanent Community Resource Board to receive input and make recommendations to the Planning Board and City Council concerning programs contained in the Consolidated Plan; and

WHEREAS, on January 2, 1996, the City Council appointed nine citizens to the Community Resource; and

WHEREAS, on January 24, 2012, the City Council directed that the Community Resource Board responsibilities related to receiving input and making recommendations to City Council concerning programs contained in the Consolidated Plan be transferred to the Planning Board; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF GREENSBORO;

Section 1. That the Planning Board receive input and make recommendations to City Council concerning programs contained in the Consolidated Plan covering the Community Development Block Grant Program, HOME Investment Partnership and Emergency Shelter Grant Program and other programs within the oversight of the Community Resource Board and that the Community Resource Board is hereby abolished.

Section 2. That this resolution shall become effective on and after July 1, 2012.
