COMMISSION ON THE STATUS OF WOMEN MINUTES

August 19, 2014

The Commission on the Status of Women (CSW) convened for its regular monthly meeting at 1:00 p.m. on the above date in the City Council Chamber, 2nd floor of the Melvin Municipal Office Building. Chair Foy presided.

CALL TO ORDER

The meeting was called to order at 1:10 p.m. by Chair Henry.

RECOGNITION OF VISITORS

Interim Chair Henry recognized and welcomed visitors.

<u>GUEST SPEAKERS – Connie Russell, Wells Fargo</u>

Mrs. Russell thanked for the opportunity to present to CSW. Mrs. Russell has been a financial advisor for Wells Fargo for 28 years; she focuses on socially responsible and sustainable investing. Within this large umbrella comes the topic with investing for woman. One way is to invest and empower women around the world and the other is perhaps entertaining the idea of starting to have women's financially well-being workshops. She would like the CSW to consider a collaboration to provide educational financial workshops, either for business or personal purposes. Women are reaching retirement with 30-40% less than men and 90% of women are responsible financial at some time in their life but most of women are really busy taken care of everybody but themselves. The workshops would be with a minimum cost to cover materials and she wouldn't charge a fee for the presentation.

Commissioner Mabry asked if she teaches only on investing. Mrs. Russell tells that she would like to do one called Financial Well Being for Women 101 including savings budgeting, shopping, economics of the women. The next would be investing.

Commissioner Peterson asked if Mrs. Russell has considered teaching these workshops in libraries or at the Women's Resource Center. Mrs. Russell answered this is her first time trying to work with other groups.

Commissioner Mabry thanked Mrs. Russell for her presentation. Chair Henry also thanked Mrs. Russell and told her she would contact her.
