## RESOLUTION ADOPTING THE 2015 GREENSBORO URBAN AREA BICYCLE, PEDESTRIAN, & GREENWAYS MASTER PLAN UPDATE

A motion was made by TAC Member <u>Cheryl McQueary</u> and seconded by TAC Member <u>Jamal Fox</u> for the adoption of the following resolution, and upon being put to a vote was duly adopted.

**WHEREAS**, this plan updates and revises the original recommendations and conclusions of the 2006 Bicycle, Pedestrian, and Greenway Master Plan for the Greensboro Urban Area; and

**WHEREAS**, offering transportation choices, improving transportation safety, enhancing community health and wellness, and a range of other community goals all depend on the provision of safe and convenient facilities for non-motorized transportation; and

WHEREAS, work on the plan has been coordinated with area transportation, planning, and parks and recreation authorities and conducted with the collaborative support of the BiPed Update Advisory Committee, which included varied interests and expertise from advocates, public health, business and government stakeholders; and

WHEREAS, work on the plan has been coordinated with NCDOT and area governments; and

**WHEREAS**, the Bicycle, Pedestrian, & Greenway planning process has included extensive public outreach and involvement in the form of multiple meetings, workshops, and surveys during plan development; and

**WHEREAS**, the Transportation Advisory Committee has provided for a 30-day public comment period for the draft plan document; and

**WHEREAS**, the plan provides a flexible set of recommendations well suited to adaptation and refinement through time; and

**WHEREAS**, the plan provides a comprehensive evaluation and program of action to address the immediate and long-term needs for bicycle, pedestrian and greenway facilities in the Greensboro Urban Area;

**NOW THEREFORE, be it resolved** by the Greensboro Urban Area Transportation Advisory Committee, that the 2015 Greensboro Urban Area Bicycle, Pedestrian, & Greenways Master Plan Update, dated November 2015, be adopted for the Greensboro Urban Area Metropolitan Planning Organization on this, the 10th day of November, 2015.
