- [Guilford CARES Small Business Assistance Grant Program](#) - ~~To mitigate the impact of COVID-19 on Guilford County small businesses and their employees, Guilford County is providing emergency financial support through the Guilford CARES Small Business Assistance Grant Program that is targeted at qualified small businesses that are negatively impacted by the COVID-19 pandemic due to Stay at Home Orders. The program will provide one-time grants of up to \$10,000 to help offset the significant, temporary loss of revenue to these qualified businesses during this pandemic and to assist businesses in retaining and paying employees. Awards will be made on a first come, first served basis. Incomplete applications will not be reviewed. - [GoFundMe Small Business Relief Fund](#) - The Small Business Relief Fund will provide one-time matching grants to qualifying small businesses to help alleviate the financial burdens during these pressing times. Donations to the relief fund will be paid out as grants to businesses that qualify, and which businesses have created a fundraiser through the Small Business Relief Initiative or had an existing GoFundMe. To qualify for a matching grant from the Small Business Relief Fund, the GoFundMe fundraiser must raise at least \$500 and verify that your small business has been negatively impacted by a government mandate due to the COVID-19 pandemic. Your small business must be independently owned and operated, and must not be nationally dominant in your field of operation. Each recipient of the matching grant must intend on using the funds to help care for your employees or pay ongoing business expenses.

They will deploy grants to help them bridge the financial gap, and provide guidance to help them navigate the intricate web of public and private resources now available. LISC will focus these efforts on historically underserved communities—especially those enterprises owned or led by minorities and women, who often lack access to affordable capital. - [NC Commerce Job Retention Grant](#)- If your business or non-profit organization experienced interruption due to the COVID-19 coronavirus pandemic, the new Job Retention Grant (JRG) Program may be able to offer assistance. On July 1, 2020, Governor Roy Cooper signed into law House Bill 1023 to create the grant program (see section 4.2B of the bill). The JRG program utilizes the Coronavirus Relief Fund to provide economic relief to North Carolina businesses and nonprofits negatively impacted by the public health emergency. The maximum grant amount may be up to two months of the eligible entity's average monthly payroll costs from 2019 plus an additional 25% of that amount. The grant amount may not exceed \$250,000. The total of all funds granted under the Job Retention Grant Program may not exceed \$15,000,000. If the total amount of grants requested by qualified applicants exceeds the maximum amount of funds available, each grant award will be reduced on a proportionate basis. - [NC Commerce Mortgage, Utility and Rent Relief \(MURR\) Program](#) - The N.C. Mortgage, Utility and Rent Relief (MURR), administered by the North Carolina Department of Commerce, can provide up to \$20,000 in relief funds per qualifying business location. Business applicants from certain industry sectors that have not been able to operate during the COVID period may apply for up to two of their business locations. Applicants can apply for up to four months of mortgage interest or rent expenses, and utility expenses. The help offers relief for some of the fixed costs a business cannot easily control on its own. Applications to the program should open next week and will be handled on a first-come, first-served basis. Applicants must certify that they were closed during the period April 1 through July 31, 2020; they expect to be able to operate after the COVID crisis has passed; and they have not been reimbursed by any other federal source for the expenses for which they seek reimbursement through this program. See website linked above for eligibility criteria. Applications are open and being accepted applications for this assistance on a first-come, first-served basis. (As of 10/27 the MURR has been expanded to include nonprofit organizations). As of 11/12/20, full-service restaurants will be eligible to apply to the Mortgage, Utility, and Rent Relief (MURR) Program. Restaurants may only request direct payments for up to four months of rent or mortgage interest – restaurants will not be eligible for utility cost reimbursement. Restaurants may request payments for up to \$20,000 per location, for no more than two locations, and must employ fewer than 50 people at the location where they are seeking assistance. This rapid recovery loan helps small businesses bridge the gap between when crisis strikes and when federal loans, insurance payouts, and other relief funds are approved, or businesses have time to recover. This is not a grant program. Repayment is expected. 9/21/20 Update: New loan terms available. The NC COVID-19 Rapid Recovery Loan Program now allows businesses to borrow up to \$250,000 with no payments and 0.25 percent interest for the first 18 months, and includes a 402-month repayment term. (The application period for the NC COVID-19 Rapid Recovery Loan Program has now ended. PBC will deploy small-dollar 0% interest loans from \$5,000 - \$10,000 depending on need with all payments deferred for the first 90 days on 48 to 60-month terms. PBC will support with wrap-around services to counsel the business through the changing landscape of commerce as a direct result of this virus. Nonprofits, independent contractors, self-employed, and more are eligible. (Applications have closed due to exceeding funding. Applications will be considered if additional funding is secured. All potential applicants are encouraged to [review their FAQ and grant information](#) before applying. Non-profit organizations are ineligible for the relief funding program at this time, but may be eligible for later rounds of funding. They will support small businesses and enterprises affected by Covid-19 across the country, especially those in underserved communities, including entrepreneurs of color, women and veteran-owned businesses that often lack access to flexible, affordable capital. Applications will be reviewed based on criteria designed to prioritize particularly challenged businesses, and the final grantees will be randomly selected from the top scoring applicants.
