

MTIP Amendments: Statewide Transit Projects

- Adds local matching funds for 7 programmed Statewide transit projects
- Adds 6 new Statewide transit projects
 - \$420,000 for Section 5310
 - \$12M for purchasing Intercity buses
 - \$313,000 for expanding transit services
 - \$120,000 for increasing human trafficking awareness and public safety
 - \$440,000 for overseeing system safety for NCDOT Rail division
 - \$122,000 for HOPE Grant
- Amendment needed for TIP consistency / potential eligibility

MTIP Amendments: MPO Area Roadway Projects



- Amends HS-2007 long-life secondary road markings in Division 7
 - Creates 'C' project break, adds ~ \$3.5M in FY 2021
- Amends R-5787 install accessible wheelchair ramps in Division 7
 - Adds \$1M in FY 2021 & \$1M in FY 2022.
- Modifies R-4707 Reedy Fork Pkwy @ US 29
 - Moves construction FY 20 to FY 21
 - Minor adjustments to funding details

MTIP Amendments: Statewide Highway Projects HB-9999 & R-5966

HB-9999 Statewide Bridge Inspection Program

- Add breaks for STI tiers
- Increases annual funding to \$3.2M from FY 21 to FY 29

R-5966 Federal Tribal Transportation Program

- Adds funding in FY 21, 22, 23
- Needed for MTIP STIP consistency only

COVID-19 Relief Funding Update

- CRRSSAA includes transit finding supplements
- Funding eligibility restricted to areas with higher operating costs (capped at 75% of 2018 op costs - CARES ACT award)
- In NC, only Charlotte, Raleigh, Durham/ Chapel Hill, and Greensboro areas are eligible


