## Review – Where we are/how we got here

**Historical Overview:** CJ Admin McNeil gave a brief overview of the formation of the GCJAC and read the revised governing ordinance to the group.

• The group discussed with ACM Davis and Deputy Attorney Andrews the next steps for recommendations on policy changes with GPD Professional Standards. Attorney Andrews explained to the group the state's personnel laws and what is considered protected information. The group continued their discussion about what information they would like to receive on complaint reviews. The group was divided on what they would like to receive from professional standards. Chair J. Webb will meet with ACM Davis to further discuss the matter.
