Report Comments:

Data Qualifications - CBOD: Glucose/glutamic acid out of range on 2/1-3, 2/8-12, 2/22-24, 2/26 likely due to problem with laboratory DI water system. Ammonia and Total Phosphorus: samples on 2/19 were not preserved within 15 minutes due to City snow delay; Ammonia: not preserved within 15 minutes due to lab error; Total Phosphorus: matrix spike out on 2/4, 2/22 due to high effluent concentration, but within 15% range; TSS: on 2/19 no initial dry constant weight calibration; City closed due to snow/weather on 2/18.

The TZ Osborne POTW recorded the following 9 violations: 1 MA flow; 2 WA CBOD, 1 MA CBOD; 2 WA ammonia, 1 MA ammonia; 1 WA suspended solids, 1 MA suspended solids.

A combined sequence of events resulted in the violations. High flows due to rainfall, construction, elevated solids inventory and a structural failure of the fluidized bed incinerator which caused a loss of solids to the effluent and also impacted the nitrification process.

We have been dealing with some incinerator maintenance issues that have caused several shut downs and increasing MLSS since December 2020. We had approximately 240 hours of downtime before we finally had a major failure in the heat exchanger resulting in the complete shutdown of incineration from February 4th $\tilde{A} \not\in \hat{A}_{\hat{L}} \hat{A}_{\hat{L}}$ 15th. During that time we had heavy rain events and ice storms which caused high flows, which on top of our elevated MLSS, caused high blanket levels in our finals and contributed to the violations. We also had a failure of our new invent mixers in our BNR system which caused us to shut those down and go back to extended aeration mode. These invent mixers have now been fixed. During the incinerator down time, we hired HILCO to haul sludge to the landfill at the cost of \$225k trying to keep our heads above water. With ongoing construction, we experienced weekly shutdowns of our RAS systems which also limited our solids removal. With the high levels of MLSS and high flow events we had to shut down all aeration to control the finals and stop some of the solids from bypassing our filter system.

We are currently processing sludge at full capacity and we have also returned to our new BNR process.

The POTW rain gage measured almost 4 inches of rain in a 5-day period in which the TZO flow averaged 58 MGD with a maximum of 71.5 MGD. Our current average flow is back to normal at less than 40 MGD (37.49 MGD).

Although the TZ Osborne facility returned to compliance for CBOD and TSS during March, the POTW is still struggling with ammonia due to high solids inventory.
