Fire Permit/Plan Review Fees

All Plan review fees shall be paid under account **FIRE PLAN REVIEWS 101-4003-04.7451**

****NOTE- If the Permit fee doesn't show a fee for each particular item, the fee is for the entire review**

CONSTRUCTION FIRE PERMITS

- **Automatic Fire-Extinguishing Systems Construction Fire Permit - \$150 per System**
- **Battery Systems Construction Fire Permit - \$100**
- **Compressed Gases Construction Fire Permit - \$100**
- **Cryogenic Fluids Construction Fire Permit - \$150**
- **Emergency Responder Radio Coverage System Construction Fire Permit - \$100 per System/Building (no cost for ERRC System Letter to Designers Request)**
- **Fire Alarm and Detection Systems Construction Fire Permit - \$150 per System/Building**
- **Flammable and Combustible Liquids Construction Fire Permit (Fee type 1) - \$100 for each tank abandonment/removal.**
- **Flammable and Combustible Liquids Construction Fire Permit (Fee type 2) - \$150 for each tank install/alter, \$100 fuel dispensing stations**
- **Gates and Barricades Construction Fire Permit - \$100**
- **Hazardous Materials Construction Fire Permit - \$100**
- **Industrial Ovens Construction Fire Permit - \$100**
- **Smoke Control Systems Construction Fire Permit - \$100**
- **Solar Photovoltaic Power Systems Construction Fire Permit \$100**
- **Spraying and Dipping Construction Fire Permit - \$100**
- **Temporary membrane structures and Tents Construction Fire Permit – No Review Fee**
- **Water Based Fire Protection Construction Fire Permit (Fee type 1) - \$100 sprinkler head replacement review. \$100 private hydrant review**
- **Water Based Fire Protection Construction Fire Permit (Fee type 2) - \$150 per building/riser for sprinkler systems. \$150 per standpipe system (new systems not associated with a sprinkler review), \$150 per fire pump, \$150 for relatable equipment, \$100 Valve Replacement, \$150 All other reviews**
- **Revision Review Fee: \$150**

OPERATIONAL FIRE PERMITS

- **ABC Permits – No Review or Fee, Fire Inspection Only**
 - **Amusement Buildings Operational Fire Permit - \$150**
 - **Carnivals and Fairs Operational Fire Permit - \$150**
 - **Explosives Operational Fire Permit - \$300 for a 90 day permit**
 - **Open Burning Fire Permit – No Review Fee**
 - **Pyrotechnic Operational Fire Permit – No Review Fee**
 - **Revision Review Fee: \$150 (except pyrotechnic and open burning which are \$0)**
- *Note:** All other operational fees will be for existing inspectors and fire investigators

FIRE PERMIT RENEWAL FEE

(for a permit time extension of 180 days for expiring permits)

- **Fire Permit Renewal Fee** - \$100 per permit (Submit permit application only through system)
- **Note:** this is available to any expired permit issued within the last 365 days. Permits exceeding that timeline shall not be eligible for renewal. If a code change occurs in those 365 days, the permit will also not be eligible for renewal. Code changes will affect code compliance with the permit and a new permit submittal will be required. Permit timelines are shown at the bottom of each permit application.

EXPRESS REVIEW FEE

- **Express Review Fee** - \$1500 for the first hour (regardless of how long it takes) and \$375 for each additional 15 minute increment (currently for Fire and Building plans only)
- **Express Resubmission Review** - \$900 per plan/permit
- **Express Review Fee Process:** Once a request is received for an express review, a plan reviewer will start the plan within 8 hours or one workday. It is preferable that these start on the next day in the morning so we can justify our time through Plan Review and Tracking timestamps and so fire recovery can bill correctly for a single days work. Once the review is complete, the reviewer will put an inspection in Firehouse noting the time (currently a 1J until a plan review fee item is added), plan review number, review time (if under an hour the time is still one hour), and fee. Only the applicant can request an express review fee. The email associated with the request shall be added to the inspection file as an attachment. Express plan reviews shall be requested via email only. Only one express review request will be allowed per day.
