**Education and Outreach:**

Education & Outreach- Commission Jalloh present the report on behalf of the education and outreach subcommittee. The education and outreach committee met on March 8, 2022.

- The group will be working on planning a roundtable discussion on addressing violence in our city. They will be reaching out to various leaders in the community (Church, Courts, Police, Civic Organizations, and youth).

The group talked about being inclusive and trying to reach out to typically marginalized people. The group also spoke about drafting a letter to send to various community organizations telling them about the commission and asking for support in the roundtable discussion.

  - The group identified its mission and scope to educate and share information with the public about law enforcement and collaborate on law enforcement solutions.

**Policy Subcommittee:**

Commissioner K. Brown provided the report from the policy subcommittee. The policy subcommittee met on March 7, 2022.

- The group discussed the courtesy policy and wanted to get information from GPD about what they are doing to address the courtesy complaints that continue to be leading external complaints about the department. A letter will be sent to GPD asking for information related to complaints. The committee is interested in learning about any auditing or evaluations conducted by the professional standards division to understand the complaints being filed.
- The group also spoke about asking to receive additional training from police attorney Andrea Harrell, Professional Standards Division, participating in the use of force simulator, and someone from the police department crime analysis department to come and do training on understanding the data on the open data portal.
- The group discussed the possibility of conducting a study of GPD training standards and comparing them to the training standards of other surrounding agencies.
- The group is interested in addressing the frequency of other municipalities incentivizing lateral entry by offering competitive pay and benefits for lateral entry.
- CJ Admin will reach out to GPD’s training and standards division Captain E. Cuthbertson to see if he would be willing to attend a GCJAC policy subcommittee meeting to discuss GPD’s training.





- The group also spoke about looking for a possible correlation between officer overwork to courtesy.
- Commissioner T. Phillips brought up the joint committee on restraints that some commission members were able to participate in 2019. He inquired about what outcomes came from the study and that it would be good to receive an update.
