Tyler Meyer called the meeting to order at approximately 2:00 PM.

Introductory Items

1. Opening remarks / TCC Roll Call /Attendee Verification

Tyler Meyer called the meeting to order and stated that the meeting is being recorded for the purpose of developing minutes. Craig McKinney then took roll call and completed the attendee verification. Meyer then briefly reviewed basic Zoom software functions and noted that the most important thing for attendees to remember about zoom is to keep themselves on mute when not speaking.

Action Items:

1. August 8, 2022 Meeting Minutes

Tyler Meyer asked if any changes were needed to the minutes. Changes identified to the attendee list including that Jason Geary, Hanna Cockburn, and Chandler Hagen were not present and that



Deniece Conway was not the Piedmont Triad RPO representative. In addition, Suzanne Akoush was present at the meeting. Meyer noted the mix up and that it would be fixed for the record. McKinney apologized, stating that he had thought he had cleaned the list up but evidently had not done so.

Mark Kirstner moved to approve the minutes. Kelly Larkin seconded. The TCC voted unanimously to approve.

2. MTIP Amendment & Modification: Roadway Projects

Tram Truong noted this amendment and modification affects two projects. The first change is to add a new “E” break to grouped safety project HS-2007. The break will provide for improved pavement markings and associated safety improvements on NC 62 from west of Thornbrook Road to west of the Alamance County Line. The action adds \$715,000 in FY 23 for that purpose.

The second project increases funding for I-40 & Sandy Ridge Road Interchange project (I-5712) by \$4.5 million based on current estimates. Construction remains scheduled for 2023.

Craig McKinney noted the I-5712 project would widen Sandy Ridge Road up to Cider Road. Tyler Meyer further clarified HS-2007 is a grouped project. It is a project NCDOT traffic safety branch identified using the Highway Safety Improvement Program methodology.

Chris Spencer moved to approve recommendation to TAC. Michael Abuya seconded. The TCC voted unanimously to approve.

3. MTIP Modification: Aviation & Rail Projects

Tram Truong noted this modification would shift construction schedules to provide more time for design and project development for two projects. The first project (AV-5711) will update service movement guidance and control system at PTI. The modification will shift construction from FY 22 to FY 25 to provide PTI more time to assemble the full funding package and complete the necessary preparatory work. The second project (Y-4807B) will realign the Lowdermilk Street, Sykes Avenue, and East Market Street intersection with a new traffic signal. It will also remove the Pine Street rail crossing and extends sidewalks and curb and gutter added under MPO supported City of Greensboro project EL-5101DM. The modification shifts construction from FY 22 to FY 23. The recommendation is to modify the MTIP accordingly.

Gray Johnston asked if the aviation guidance and control system update is part of routine maintenance or if the current system is very old and outdated. Alex Rosser explained the project is to install a Surface Movement Guidance and Control System. SMGCS is a series of flashing pavement lights on the taxiway system that allow pilots to taxi and navigate in low visibility. The project is done in phases. The work needs to be shifted to FY 23 to allow the taxiway to be resurfaced before the lights are installed.

Gray Johnston asked if the Sykes Avenue and Lowdermilk Street alignment is a Complete Streets project that uses NCDOT funding. Tyler Meyer replied that it is a rail division safety including complete streets features connecting to MPO supported project EL-5101DM that retrofitted Holts Chapel and Lowdermilk with curb and gutter and sidewalks. Bicycle lanes were added to Holts Chapel but on Lowdermilk, the houses are set too close to the street for that to have been possible. McKinney asked Johnston were bus shelters should go on the project. Johnston said around the intersection inbound and outbound, and that he would follow-up with McKinney to seek to make arrangements.

Chris Spencer asked if this project will be complete before the Franklin Boulevard grade separation project (P-5709) starts. Meyer agreed that would be highly advisable under the circumstances. Stephen Robinson agreed that ideally it will be but that he did not have the precise scheduling information available at the time.

Hannah Cockburn moved to approve recommendation to TAC. Kelly Larkins seconded. The TCC voted unanimously to approve.

4. MTIP Modification: Roadway and Rail Projects

Tram Truong noted this item shifts right-of-way from FY 22 to FY 23 for the Summerfield South Greenway (EB-5900) to allow for additional planning. Construction remains in FY 24 and funding amount does not change at this time. The item also shifts the right-of-way from FY 22 to FY 23 for the Benjamin Parkway sidepath project (EB-5986). The project includes pedestrian signals and sidewalks or sidepath where needed from Battleground to Elam. There are no change to construction schedules or funding amounts at this time.

Meyer explained some of the needed sidewalks are in front of the Kiser Middle School, which Guilford County Schools plan to renovate and reconstruct in the near future. Sidewalks are expected to be included in that construction, but if something changes and that does not occur, they can be constructed under EB-5986. Hannah Cockburn suggested showing the full length of the project to Elam Avenue on the included map for clarity for the TAC meeting.

Hannah Cockburn moved to approve recommendation to TAC. Mark Kirstner seconded. The TCC voted unanimously to approve.

Business Items / Potential Action Item(s):

1. Division Engineer Updates

Stephen Robinson delivered the Division Engineer Report. Robinson displayed a drone photo of the urban loop taken August 29 and described progress on the project. Construction is ahead of schedule and completion is expected in by spring 2023 or possibly sooner based on current rate of progress.

2. Project Updates

Jason Geary provided an update on recent and upcoming locally administered projects.

- Value engineering is underway for the revisions to Downtown Greenway Phase 4 project. Staff plans to put out to bid in December 2022 with the goal of a construction start in May 2023. Changes under way include the removal of enhancement area along the Greensboro College campus and removal of the extension of the A&Y Greenway from Smith Street to Benjamin Parkway which will be added to the next phase of A&Y Greenway construction.
- The Greene Street Streetscape project is set to begin construction once the necessary water line materials are delivered in January 2023.
- The Alamance Church Road improvements are underway and going well. Clearing and private utility relocations are complete, and new water line and storm sewer installation is ongoing. Widening is underway in areas where utility installations are complete. Construction completion is expected by spring 2024.

- Construction on the Ballinger Road Bridge continues apace after various delays in obtaining necessary supplies. Utility installations are complete and widening is in progress. Completion is expected by December 2022.
- The water line was installed for the Eugene and Bellemeade Streetscape project. Now that is completed, the roadway project will restart November 1.
- Construction of the Horse Pen Creek Road Widening is substantially complete.
- Work on the Summit Avenue Streetscape Project is underway. Utility work on phase one is complete. The work on Yanceyville Street is expected to be complete by the end of the year. Once phase one work is complete phase two will begin.
- The College and New Garden Road Sidewalk project and the North Elm Street Sidewalk project are going well and completion is expected by the end of the year.

Tyler Meyer noted NCDOT recently began feasibility studies for two rail grade separation projects that the MPO had previously submitted for prioritization in consultation with the Rail Division. These studies are intended to validate and define the scope of each project and estimate the probable cost. The first project is the Yanceyville Street grade separation (P-5735). This project is listed in the Draft STIP for preliminary engineering only and is subject to reprioritization. The second project is the South English Street grade separation (P-5747). This project is programmed for construction in FY 26 in the draft STIP and is not subject to reprioritization.

3. Strategic Reports

Tyler Meyer noted NCDOT recently began feasibility studies for two rail grade separation projects that the MPO had previously submitted for prioritization in consultation with the Rail Division. These studies are intended to validate and define the scope of each project and estimate the probable cost. The first project is the Yanceyville Street grade separation (P-5735). This project is listed in the Draft STIP for preliminary engineering only and is subject to reprioritization. The second project is the South English Street grade separation (P-5747). This project is programmed for construction in FY 26 in the draft STIP and is not subject to reprioritization.

MPO staff completed and submitted the grant application for the USDOT Safe Streets and Roads for All discretionary grant opportunity that he had mentioned at the last meeting. The purpose is to secure funding to develop a Comprehensive Safety Action Plan for the MPO area.

Work began on the Downtown Parking Plan last month. The consultant is in the early phases on that project. This includes preliminary stakeholder engagement and a City Council briefing later in the month to update City Council on the initiative

MPO staff has completed the scope of work for the Mobility Greensboro 2045 Long Range Transit Plan in coordination with GTA. The Request for Letters of Interest will be issued shortly with letters of interest due by November 10.

Staff is analyzing the need and potential for project swaps in the Draft 2024-2033 STIP and is actively coordinating with Division 7 on that endeavor. The results and recommendations from this work will be presented for TAC consideration at future meetings.

Meyer noted that a conflict has arisen for the currently scheduled November MPO meeting dates. He asked whether rescheduling that TCC meeting to November 14 would work for TAC members. This will resolve a conflict with the November Prioritization Workgroup meeting and will avoid the

week of Election Day and Veteran's day. Kirstner asked if Meyer thought TCC might eventually go back to Wednesday morning meetings. Meyer stated no, having a day or two between the meetings had proven to be quite helpful. Members present agreed to the change assuming TAC agrees to shift their meeting to November 16 as well.

Meyer concluded with an introduction of Raunak Mishra, recently hired into a new MPO Transportation Safety Engineer position. Mishra began his career in the National Rural Infrastructure Development Agency in India where he gained valuable on the ground experience. He then then came to the US for advanced studies, recently completing his PhD at UNC-Charlotte in transportation engineering with a focus own transportation safety. The TAC warmly welcomed Mishra.

4. Wrap-Up & Adjournment

Tyler Meyer noted the TAC meeting date 9-20 and noted McKinney would play a high resolution seven minute drone video of progress on Urban Loop construction following adjournment, and invited anyone interested to stay on the line to watch it. Meyer thanked everyone for attending.

Tyler Meyer adjourned the meeting at 2:40 PM.

FY 2020-2029 MTIP Amendments and Modifications: Statewide Projects

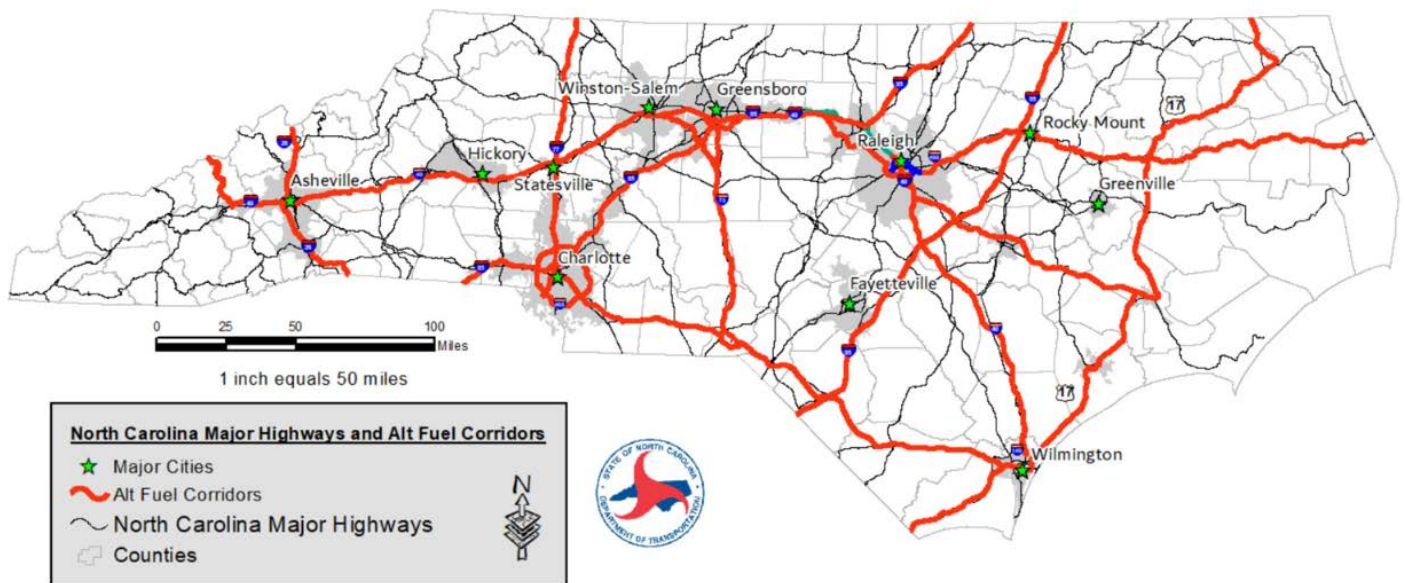
Background:

The NCDOT requests the MPO amend and modify the 2020-2029 MTIP for five statewide projects. The projects include statewide traffic operations, construction of electric vehicle supply equipment along North Carolina's Alternative Corridors, and various utility encroachment and administrative activities. The MTIP action is necessary to maintain MTIP/STIP consistency and to enable the projects to include work in the MPO area as needed.

Project Situation:

This action amends four projects and modifies one statewide project.

- **HO-0010B:** Implement statewide traffic operations activities such as traffic management centers, traveler information, ITS, and traffic incident and event management across the entire state. *Adds project to MTIP.*
- **HV-0001:** Construct electric vehicle supply equipment along NC Alternative Corridors. *Adds project to MTIP.*
- **M-0555DIV, M-0555REG, M-0555SW:** Various utility encroachment and administrative activities. *Adds projects to MTIP*



Recommended Action & Next Steps:

- TAC action to amend four statewide projects HV-0001, M-0555DIV, M-0555REG, and M-0555SW and modify one project HO-0010B for the FY 2020-2029 MTIP.

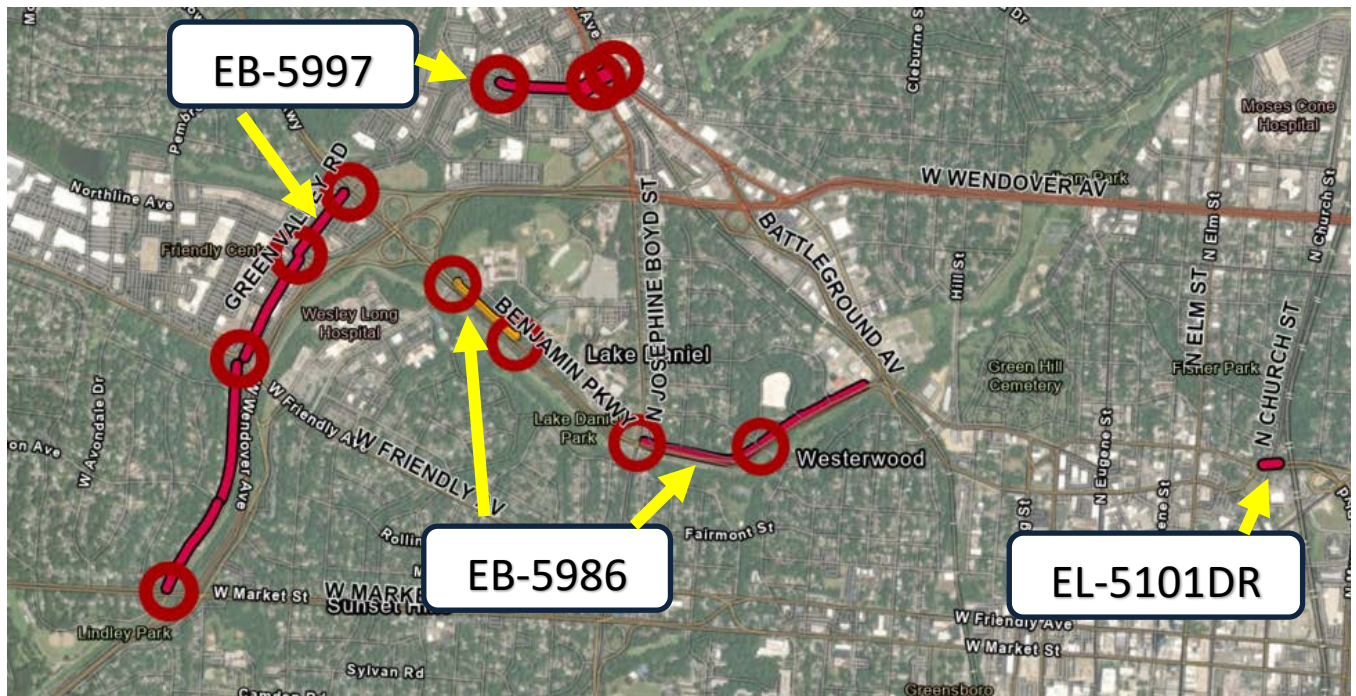
FY 2020-2029 MTIP Amendments: MPO Area Pedestrian and Bicycle Projects

Background:

NCDOT requests the MPO amend the MTIP for four pedestrian and bicycle projects.

Project Situation:

- **EB-5986** will construct a greenway sidepath to connect N. Josephine Boyd St / Grimsley High School area to the future A&Y Greenway and the pending Seminole Drive sidewalk project. Also adds pedestrian signals and sidewalk where needed between Elam Ave and Battleground Ave. *Adds Preliminary Engineering (PE) in FY 2023.*
- **EB-5997** will construct sidewalks and pedestrian signals where needed on Green Valley Road from Market Street to Battleground Avenue. *Adds PE in FY 2023, shifts right of way from FY 23 to FY 24.*
- **EL-5101DR:** Repair Bridge Deck on Murrow Blvd over Church Street and complete greenway across structure. *Replaces EL-5101DJ with a new break EL-5101DR and adjusts the total funding amount based on the most recent cost estimates. This updates the action on the item EL-5101DJ August 10, 2022.*
- **R-5787:** Division 7 program to upgrade intersections to comply with the ADA using Transportation Alternatives (TA) funds. *Adds funding FY 2023.*



Recommended Action & Next Steps:

- TAC action to amend four projects EB-5986, EB-5997, EL-5101DR, and R-5787 for the 2020-2029 MTIP.
- NCDOT amended the 2020-2029 STIP for four projects at the October 6, 2022 Board of Transportation meeting.

WHEREAS, the amendments will add preliminary engineering in FY 2023 for project EB-5986; add preliminary engineering in FY 2023 and shift right of way from FY 2023 to FY 204 for project EB-5997; replace EL-5101DJ with a new break EL-5101DR and adjusts the total funding amount based on the most recent cost estimates; and add funding in FY 2023 for project R-5787; AND

WHEREAS, NCDOT amended the 2020-2029 STIP for projects EB-5986, EB-5997, EL-5101DR, and R-5787 at the October 6, 2022 Board of Transportation meeting; AND

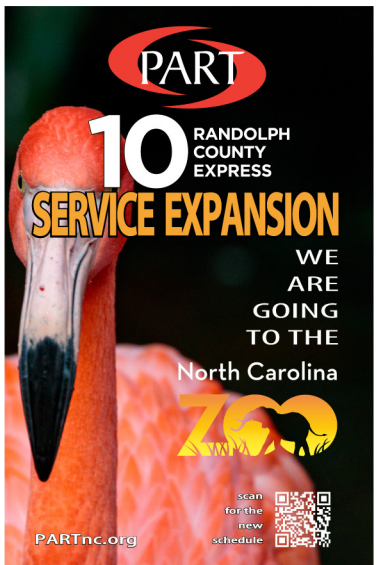
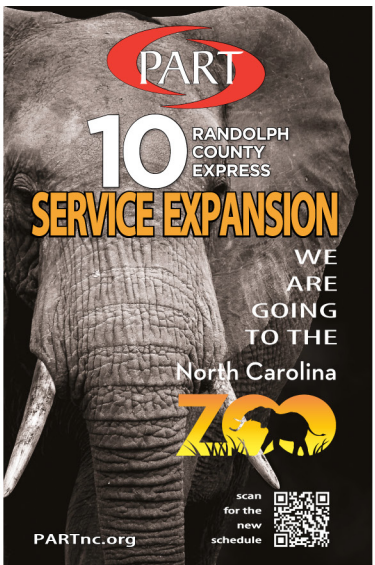
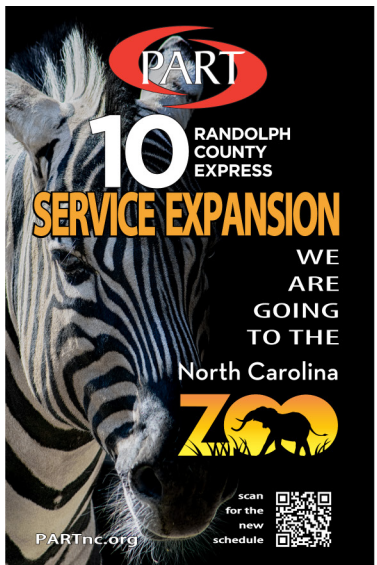

PART Is Going To The Zoo!

In a collaborative effort to gauge Randolph County residents' transportation needs, the City of Asheboro, the Regional Coordinated Area Transportation Service (RCATS), and PART recently distributed a survey to gather data in the region. In addition, Randolph County, the YMCA's Asheboro branch, Randolph County Community College, Christ United Outreach Center (CUOC), and the Asheboro Housing Authority partnered to help collect the information. The response was excellent, and we were able to provide reliable data for our planners to work with.

As a result, we expanded our Randolph County Express Route 10 service effective 8/1/2022. Community interest drove PART's expansion to include a stop at the North Carolina Zoo. Again, collaboration played a key role, and working with our North Carolina Zoo partners, PART landed a front door stop at the North American entrance. Messaging about the service expansion started going out to the public in mid-August utilizing a series of four ads, published as print and web-based, running for eight weeks, along with a series of four email campaigns through Triad City Beat, a local publication that focuses on the Triad (triad-city-beat.com).

In addition, PART and several of our Randolph County partners ran email campaigns, put out posters, and ran web ads and social media blasts through various platforms. The messaging will continue through October and include an ad going into the city of Asheboro's quarterly newsletter. PART also has a tab on the North Carolina Zoo website! nczoo.org/visit/part-bus. Explore With Express.

Route 21 NE Chimney Rock Express is another workhorse of a route. This service runs 6:15 am - 8:45 pm out of the Coble Transportation Center, getting riders to and from work and school. With stops at Harris Teeter Perishable warehouse, two GTCC Aviation centers, HAECO, Harris Teeter Distribution Center, and the Industries of the Blind Distribution Center, this route makes the stops! An added bonus, this route connects with Greensboro Transit Authority's (GTA) route 9 bus at our Swing Road stop. Connecting Communities, that's what we do!

Triad Travel Counts.

Our local Metropolitan Planning Organizations, known as MPOs, staffed by your neighbors and local residents, will launch a vital survey this fall called **Triad Travel Counts**. This research data is only gathered approximately every ten years, so the information is crucial to our region. PART is collaborating with the MPOs in our area to conduct the study. This is a rare opportunity for households to provide vital information that will help set transportation priorities for many years. The insights gained from this survey will help prioritize local transportation projects, improve mobility, and reduce congestion.

Communication to the public about the study will include public relations campaigns, web, social media, email campaigns, and print. This survey will collect details about how residents get around the region, whether going to work, shopping, visiting family or friends, or finding entertainment. MPOs will use this data to understand how our transportation systems currently work for citizens and help us decide where things can be improved. Is it money? Is it the environment?

What drives mobility choices? Even with more commuting alternatives popping up in our local cities, there is still a heavy dependence on private cars. Therefore, understanding the motives influencing how people decide to commute is vital for developing our local mobility needs and a significant factor in driving the transition to greener options.

According to data from the World Economic Forum, 70% of the world's population will be living in cities by 2050. In the next five years, there will be an explosion of mega-cities with more than 10 million people, roughly 50% more than today. This massive urbanization will pile on our cities' existing problems, such as urban sprawling, transportation options and reducing inequalities, and fostering innovation. But by far, the biggest challenge we will face is reducing the environmental impact.

A recent study published by the C40 Cities, a Climate Leadership Group of 97 cities around the world that represents one twelfth of the world's population and one quarter of the global economy, indicates that public and private transportation can represent up to 20% of city greenhouse gas emissions. Positive incentives to drive behavior change are likely to be effective. Still, for them to work, planners need to understand users' preferences, values, and interests, how these evolve, and any differences between geographies and generations. Jumping out in front of these trends, PART works diligently to gather data and work with our local Metropolitan Planning Organizations (MPOs) and citizens to find solutions. We are doing our PART to stay on top of connecting our local communities in ways that save our neighbor's money and protect our environment. Real-time Bus Tracking ... its a thing!

PART is transitioning our Automatic Vehicle Locator (AVL) system that assists riders with trip planning and understanding where our vehicles are in real-time. Currently, we are using Transloc; our new platform will be GMV. This process will take several months and went in testing on 08-12-2022.

During this transition, we may experience disruptions with Transloc which will remain our platform until the end of the conversion. Throughout the transition, PART will provide updates and information related to the new platform on our website and updates on any disruptions.
