Sealed proposals will be received by the City of Greensboro, NC in the Engineering Conference Room (Room 313) located on the 3rd floor of the City of Greensboro's Melvin Municipal Office Building until **2:00 p.m. local time**, on **Thursday, February 1, 2024**, for the above listed contract as shown in the plans and described in the Special Conditions. At said time, they will be opened and read publicly. The Melvin Municipal Office building is located at 300 West Washington Street, Greensboro, NC 27401. The Bid Opening will also be available via Zoom.

This contract consists of approximately 3300 feet of streetscape, roadway, storm drainage, and utility improvements, including the installation of approximately 1400 linear feet of proposed storm sewer and 3030 linear feet of proposed water line.

All bidders must obtain Bid Documents by registering with the City's Engineering & Inspections Department. If desired, hard copy Plans and Specifications may be purchased from the City of Greensboro for a nonrefundable fee of \$150.00 payable by check to "The City of Greensboro". Mailing costs will be \$25.00 per set or charged to the contractor's shipping account. Neither OWNER nor ENGINEER will be responsible for copies of the Bidding Documents obtained from sources other than the City of Greensboro.

No proposal shall be considered or accepted by the City unless at the time of its filing the same shall be accompanied by a five percent bid security as indicated in the Instructions to Bidders.

A separate performance bond and payment bond each in an amount equal to one hundred percent (100%) of the contract price will be required of the Successful Bidder following award of the Contract by the City.

Consideration will be given only to proposals submitted by contractors licensed in the state of North Carolina under the Contractor's Licensing Act of 1925 or as amended.

Sealed proposals and M/WBE Good Faith Efforts must be submitted on the blank forms provided and as specified in the bound copies of the contract documents. This is a non-bifurcated bidding process; however, the Proposal and MWBE Documents should be enclosed in two different sealed envelopes addressed to Ms. Kristen Kollgard, Engineering Division, 300 West Washington Street, Suite 332, Greensboro, North Carolina 27401. The outside of each envelope shall be plainly marked with the Project Name; Contract Number;

the name, address and license number of the Bidder; and with the notation "BID ENCLOSED" for the envelope containing the Proposal and the other envelope with MWBE Affidavits noted as "MWBE DOCUMENTATION".

A non-mandatory pre-bid meeting will be held at **10:00 a.m. Thursday, January 18, 2024** in the Melvin Municipal Office Building 3rd Floor Engineering Conference Room located at 300 West Washington Street, Greensboro, NC 27401. The Pre-Bid Meeting will also be made available via Zoom. All plan holders and other interested parties will be emailed the Zoom meeting link along with the Meeting ID and any applicable password prior to the Pre-Bid meeting. City of Greensboro personnel will discuss M/WBE requirements and the Engineer will be available to discuss the Contract and answer pertinent questions. Attendance is strongly encouraged.

The City reserves the right to waive any informality or to reject any or all bids or to award such contract as in its judgement is deemed to be in the best interest of the City.
