Call to Order

Chair Doug Bender called the meeting to order at 6:01 pm.

I. Moment of Silent Meditation

Chair Bender noted a slight change in the agenda, having moved the election up to allow for some who needed to leave early to participate in the election. Bender called for a moment of silent meditation.

Committee Reports

Chair Report

Chair Bender noted that it was a bittersweet moment, as it was his last meeting as chair and commissioners. As usual, he had been immersed in community engagement efforts to further human rights work in Greensboro. He had chatted earlier that day with a woman who wanted to start a Human Relations Commission in New Bern and noted the importance of connection with other leaders across the state who were engaged in similar work. He expressed his support for the work of Sue Polinsky and Kentia Smith on the Let's Talk Law series, sharing his hope that the Let's Talk Law series could turn into the Let's Talk series, branching out into other topics in the future.

Bender also shared that he'd been active with the MLK day production and believed that all would be proud of the final product. He had also been volunteering with the Community Sustainability Council to ensure that the conversation around sustainability and equity didn't get lost in the shuffle. He was also serving as a commissioner on the Cultural Affairs Commission and while he was excited about the work they would accomplish, he was so thankful for all of the commissions for their energy and hard work, and expressed thanks to staff for their support and guidance. He finished with gratitude for Marikay Abuzuaiter for being an excellent, committed council liaison.

Bender expressed desire to support the work of the HRC in the future.

Election

Commissioner Sue Polinsky nominated Commissioner Shon Smith as Chair. Commissioner Shon Smith accepted the nomination. All unanimously agreed that Commissioner Shon Smith should be elected as the Chair. Bender congratulated Smith.

Commissioner Bob Kollar shared that while he was happy to serve as vice chair, he was delighted to nominate Kentia Smith as Vice Chair. Commissioner Kentia Smith accepted the nomination. All unanimously agreed that Kentia Smith should be elected as the Vice Chair.

Education Committee

Commissioner Sue Polinsky provided an update on the next Let's Talk Law series, for February 3, which would be the session on Probation, Parole and Plea Bargains featuring FJ Carney and Sharon Dunmore. March 3 session was entitled "Can They Do That?" led by an Elon professor who had an extensive background in 4th amendment search and seizure laws and policies. April's session would focus on immigration, though they would need to figure out what to focus on. May's session would focus on Transgender Rights in partnership with TTF and Melvy Shaw with Guilford Green. Melvy had already been very helpful in identifying a potential speaker, as well as providing general language to use. They also covered policies that were underway.

The planning committee had also brainstormed about how to expand the series in the future, covering health or perhaps money and finances. Polinsky noted that she would be reaching out to commissioners for their feedback on future sessions.

Employment Committee

Commissioner Akeylah Campbell was not present.

Human Services and Social Equity Committee

Commissioner Kentia Smith organized the homeless memorial, December 21 as the winter solstice and a time to honor and memorialize the 60 homeless people they'd lost that year. If anyone wanted to volunteer or donate to an upcoming effort - on January 26 around 7 pm, they would be counting clients needing services until about 5 am the following morning.

Chair Bender expressed his admiration for all of the work that she was able to accomplish every month.

Montgomery-Wells Housing Committee

Commissioner Bob Kollar shared that he didn't have anything to report at this time.

International Advisory Committee

Jodie Stanley shared that their most recent event focused on mental health and homelessness which was especially challenging for non-English speakers. They hoped to make some progress in addressing these issues.

Staff Report:

Dr. Love Jones shared her appreciation for Chair Bender's incredible leadership during his tenure as chair.

Jones shared that the MLK program for this year was outstanding. The committee's hard work was evident. The production would air on January 17 at 9 am, and would feature Nikki Giovanni.

She also shared about an exciting partnership with The Poetry Project, a civic engagement series geared towards people 10-18 called Voices of Change. Once a month, young people would hear from our bodies to get a better understanding of why they were serving as commissioners, exploring topics like what it meant to be black in Greensboro, experiences of women in Greensboro, and more. The goal was to empower young people with information and get them excited about getting involved. After each informational workshop, the students would then create work and showcase their work at an event later that month.

Jones noted that the meeting schedule would be important to discuss. With the new variant, the likelihood of convening in person was low. However, they could still explore the option of getting together on a quarterly basis with all other bodies. Some bodies were open to allowing the quarterly meeting to happen during their meeting, others were reticent about offering up their monthly meetings because they needed them to conduct meetings. Polinsky asked if the quarterly meetings would replace theirs, or be in addition to their monthly meetings. Love agreed that the concern was valid, so staff would provide a calendar providing multiple options.

Jones introduced all to Liz Lennon, the department's new Commissions Administrator, who had a long background with the City and with the Parks and Recreation Department. She had extensive experience with volunteer bodies as well, was very savvy and had great ideas. Jones thanked Stanley for supporting the department in the interim and being a team player to ensure that commissions were supported.

Liz Lennon shared that she was excited to get to know commissioners and work with them. She shared again that she had a strong background in supporting volunteer bodies and organizing outreach events.

Chair Bender welcomed Lennon, stating that he believed the commission was poised to accomplish some really great things in 2022.

Chair Bender shared that Zanzella Savoy had resigned due to personal reasons. He asked Council Member Marikay Abuzuaiter to support him in his efforts to get more people identified and appointed to the Commission. Dr. Love Jones also encouraged commissioners to encourage people they knew to apply and submit interest forms. Commissioner Polinsky asked if there was a limit to the number of people who could serve from each district. Jones replied yes, there were a number of stipulations that complicated the process and the number of people that could serve from each district.

Chair Bender invited Marikay Abuzuaiter to share her thoughts before closing the meeting. Abuzuaiter shared her gratitude for the work Bender had poured into the role of Chair, noting various outreach events and projects the commission had taken on in the past year, highlighting the name change as well. She thanked him for the legacy he was leaving.

Commissioner Polinsky shared that she had a new piece of business, a concern that she wanted to bring forward. As many knew there was an anti-Semitic flyer circulated and the City in general responded, as did the Police Department and others. She expressed frustration with the lack of response from the Human Rights Commission itself. She expressed a desire to better understand the process when it came to communications processes. She suggested that it could perhaps be an agenda item in the future.

Dr. Jones thanked Polinsky for her candid question and expressed appreciation for her concern. She shared that they followed the normal protocol that was used for responses in the past, because the messaging itself didn't rest on a commission or department. There was a division called Race GSO that usually headed up the process of public statements, and the department was a supporting partner as they had been in the past. Because this body was such a critical voice for the community, Jones suggested that it might be possible to alter existing protocols to ensure that there was more involvement from the commissioners with future statements.

Polinsky shared that she was simply disappointed, she would have loved to see it circulated to all of the commissioners. She understood the City was complicated and approvals were needed on every level.

Commissioner Kollar shared that anytime he did work, he would consider who needed to know.

Call to Order

Chair Doug Bender called the meeting to order at 6:05 pm.

I. Moment of Silent Meditation

Chair Bender wished all happy holidays and called for a moment of silent meditation.

Committee Reports

Chair Report

Chair Bender shared that he had participated in the planning of the MLK event, noting that Jodie Stanley would share more about the details of the event later. He also noted that he was a member of the new

Cultural Affairs Commission and would share more about that later. Bender reminded all that the statewide HRC retreat was coming up soon and he encouraged all to attend if they were able. He thanked the commissioners who were involved in organizing the Let's Talk Law series, saying that it was and excellent example of the impact the commission could have on the community.

Education Committee

Commissioner Sue Polinsky provided an update on the last Let's Talk Law series, sharing that she received really great feedback on it. The speaker did an incredible job. She encouraged all to mark their calendars for February 3, which would be the session on Probation, Parole and Plea Bargains.

Employment Committee

Commissioner Akeylah Campbell shared some of the information on the education series with her coworkers and they were also interested in participating. She expressed excitement for the committee's next steps.

Polinsky asked if council members ever shared their events. Council member Abuzuaiter said she'd be more than willing to share events, that she often did. Stanley noted that she had not created a Facebook event for the second session but would for the third.

Human Services and Social Equity Committee

Commissioner Kentia Smith shared that she had been participating with the Let's Talk Law series and she was very happy with their success with that series. She invited all to Center City Park on December 16 for a holiday event for the homeless. The week of Christmas they would be having an annual memorial to commemorate homeless people who were lost that year. There was also a walk on December 21 that she invited them all to participate in.

Montgomery-Wells Housing Committee

Commissioner Bob Kollar shared that he didn't have anything to report at this time.

International Advisory Committee

Jodie Stanley shared that their most recent event focused on mental health and homelessness which was especially challenging for non-English speakers. They hoped to make some progress in addressing these issues.

Commissioner Kollar suggested that an immigration attorney would be a great addition to the Let's Talk Law series. Stanley stated that she knew an attorney who could assist with an overview. Commissioner Kentia Smith noted that she and other agencies could use information on how best to assist non-English speakers. Polinsky asked Stanley to set up a meeting for the committee to discuss.

Chair Bender asked if anyone else would like to share updates. Commissioner Shon Smith shared that he had been volunteering with the MLK planning committee and was organizing a watch party subcommittee to organize watch parties for the event on January 17.

Commissioner Ivan Cutler shared a brief update on the human rights calendar process, noting that he hoped to have a draft in the next 6 months or so. The calendar had the potential to brand Greensboro as an inclusive city.

Cutler also noted that the following day, December 10, was Human Rights Day and that the HRC should recognize it. Stanley noted that communications was already working on a social media post that should be ready to post the following day. Commissioner Shon Smith asked if it was possible to ask City Council to pass a resolution. Stanley stated that more lead time was needed, typically 5-6 weeks. Councilmember Abuzuaiter shared that resolutions always happened on the first meeting of the month. Kollar asked Stanley to ensure that a few quotes from the actual UN agreement be included in the statement.

Polinsky noted that the calendar would be full of many holidays for many faiths, and how was this information to be used? Chair Bender and Commissioner Cutler noted that the calendar was a work in progress and they would work out these details with the help of a committee.

Chair Bender shared that he'd spoken with Commissioner Savoy. She was healing well and while she was absent, she was with them in spirit and very excited to see everyone again.

Staff Report:

Jodie Stanley shared a brief update on the MLK event, noting that she'd recorded keynote speaker Nikki Giovanni that afternoon and planned to record the faith message of unity the following day. She also passed along Dr. Jones' suggestion that all commissions meeting together quarterly, and finished by saying that they could expect a new staff member that would start the following week.

Commissioners Kentia Smith and Kollar shared their support for quarterly meetings. Polinsky noted that 4 a year seemed excessive, perhaps it could be twice a year. All expressed general support for this meeting schedule.

Commissioner Kollar expressed his appreciation and support for the Greensboro community, noting that it was the reason big companies were willing to come. Commissioner Kentia Smith shared that she often used transporation services and would love to provide feedback, as she often saw areas for improvement. She asked Councilmember Abuzuaiter to share information about the types of jobs that would be coming to Greensboro. Councilmember Abuzuaiter responded that she didn't yet have the information but if Commissioner Smith could send an email requesting it, she would pass it along when it was available.
