Call to Order

Chair Crystal Black called the meeting to order at 6:05 pm.

II. Moment of Silent Meditation

Chair Black mentioned the passing of community leaders Timothy Vincent and Commissioner Carolyn Coleman. She then asked for Councilwoman Hightower to offer reflection on their impact within the community before the moment of silent meditation. Councilwoman Hightower expressed the longevity of Commissioner Coleman's work and how she served as a mentor to her. She also mentioned the great work of Tim Duncan through youth coaching and serving as a community advocate. Chair Black asked committee member Eugene Blackman if he wanted to share any reflections and he reiterated on their impact towards the community and prayer for their families. Chair Black then proceeded with the moment of silent meditation.

III. Introduction of Visitors:

Chair Black opened the floor for visitors. Visitors included Kimberly Nelson from Global Impact of Charlotte, NC introduced herself and expressed interest in learning more regarding ACAAD. She currently served as Vice Chair for the 12th Congressional district and served on the Chamber of Commerce as Legislative Chair and passionate about quality education. Saket McConnell who is a



resident of Greensboro and interested in the Health and Housing committee. Kaitlin Graham also a visitor who is a community advocate interested in learning more about ACAAD.

Chair Report

Chair Black mentioned sending a preliminary email during the holidays to the committee and mentioned the report basically initiated moving forward in 2022. Excited about the new ideas and the discussions with Dr. Love and Liz Lennon regarding the next steps for ACAAD. She also mentioned discussing in the last meeting not to spend a lot of time reading reports verbatim and reading the ones submitted.

Housing and Health Report

Committee member Keayba Worthington first expressed condolences to Commissioner Coleman and Timothy Duncan and then proceeded to discuss the new research resources both affiliated with the Greensboro Health Disparities Collaborative that focuses on outreach programs. The topics with the most inquiries and a tentative agenda are "Emergency Transitional Housing" and 'Health Equity". The committee is also working on the "Housing Hang Out" on February 4 on Managing Equitable Communities as a topic.

Work Force Development Group

Committee member Sanaa Sharrief reports on a having a workable survey and making connections with the NC works and serves as a liaison for certain individuals of certain populations. Also discussed building more strategies for the survey. The goal is to have a hundred surveys completed by June

Education Committee

Committee member Jasmine Getrouw-Moore mentioned being very busy working with the community regarding voting in the spring and working towards Guilford County school bond and assuring people are positioned to speak on educating residents on wearing mask. Working on a "Teach in Session" on February 10 and 24 to prepare individuals on voting in the spring. Visitor Margaret Arbuckle spoke on the Pre-K initiative called "Ready Ready" which focuses on assistance for parents with small children in the community. She mentioned sharing the information with Chair Black for those who are interested.

Staff Report

Chair Black aske Dr. Love to blend the Economic Development and Criminal Justice committee with the staff report. Dr. Love agreed and proceeded to discuss the impact both committees are capable of making for this upcoming year. She also mentioned the deliverable actions on the table from the October meeting regarding the feedback for the ACAAD survey that is being developed. Dr. Love mentioned the foot print that the ACCAD committee could establish with this survey being placed in the hands of the community verses the police department. She then shared a power point presentation of the CSW Women's Survey 2022 and the steps taken to make the survey development a success. Dr. Love navigated through each step of the survey process providing tips on how to create the survey, and the timeline



development for the survey. She also mentioned Liz Lennon as the point of contact for members regarding questions and guidance. Dr. Love also discussed the Economic development subcommittee goals and that is to create a 3 tier incubator effort for black business starting with process of ideation start up and flourishment for business. This will be a great opportunity for black businesses.

Lastly, Dr. Love introduced Liz Lennon as the Commissions Administrator. Liz spoke on the excitement and looking forward to working with everyone.

Call to Order

Chair Crystal Black called the meeting to order at 6:01 pm and welcomed everyone to the meeting.

II. Moment of Silent Meditation

Chair Black asked for a moment of silence for those who have passed.

III. Introduction of Visitors:

Acknowledged Co-chair Blackman of the ADCAAD committee and asked if he had any words. Chair Black proceeded to recognize visitors. Commissioner Sue Polinksy of the Human Rights Commission and interim Dr. Carla Coates of NCAT of the Criminal Justice department thanked the committee for the welcome. Chair Black then introduced the featured visitor for the meeting Professor Andrew Kuo from NCAT and thanked him for attending and allotted him time to share information regarding the police survey that the committee is working on.

Professor Kuo introduced himself and mentioned meeting with the committee regarding the survey and after reviewing the questions submitted, has already seen some room for improvement. He also mentioned sharing information with undergrad students who has expressed interest in partnering with the survey and design part. Moving forward he will remain in contact and meet with committee members on how to move forward with the survey.



Chair Black mentioned stepping out of order with the agenda and addressing the committee reports first and the chair report last so that sub chair Cedric Parker and Arthur Durham of the Criminal Justice committee can speak more in detail on the survey.

Criminal Justice

Committee Chair Cedric Parker mentioned meeting with the ACAAD committee and being very excited about the survey and working with everyone. He also mentioned reaching out to the community regarding thoughts on the police and gathering data to build a survey and analysis of how law enforcement reacts with the community.

Committee member Arthur Durham mentioned as the overseer of the program he desires to get a more qualitative approach and data on community engagement towards the survey.

Housing and Health

Committee member Zelma Higgs reported for Committee Chair Keayba Worthington In her absence. She shared that the committee met on February 15 and the involvement regarding the planning of the Fair Housing luncheon as well as future "Hot Topics". The committee is also looking into assessment tools to engage better with the community.

Education Committee

Chair Black confirmed if committee chair Jasmine Getrouw-Moore was present to share the education report and proceeded to move on after no response. Due to this, there was no information to report.

Economic Development

Committee Chair Chuck Byrd mentioned that he does not have a report. He also shared that he does not like not having anything to report however he has spoken to Gene regarding the committee but will be working on the incubator process.

Workforce Development

Chair Black mentioned the absence of Committee Chair Sanaa Sherrieff and asked if anyone was able to present on her behalf. Chair Black mentioned that the group has been meeting and if he gets connection with his phone he will be able to present later. Chair Black revisited this committee before proceeding with the staff report and Co-chair Blackman was able to share information in the chat regarding the group that read "Workforce Development met last week. We have put together a survey around employment".



Chair Report

Chair Black mentioned she did not have much to report however happy to see the committee is moving forward with the process and appreciate everyone who is involved. She also revisited recognition of visitors to recognize Councilman Hugh Holston.

Councilman Holston thanked Chair Black for the invite and mentioned leaving early due to another meeting. He expressed being very excited about the survey and thinks it will be of great help to the African American community. Councilman Hugh Holston mentioned being thankful to Chair Black and encouraged members to reach out at any time.

Chair Black also mentioned that the survey date has been pushed back and thinks this is best so that the committee may gather all of the information needed for the survey's success.

Staff Report

Dr. Love, director of the Human Rights Department thanked everyone for attending and mentioned tagteaming with Commission Administrator Liz Lennon to present some information regarding quarterly engagement but will begin first with some critical announcements.

She asked to familiarize everyone with the ACAAD trajectory and that is once the committee was established and got the ball rolling that there would be a two-year evaluation period and up for evaluation in 2023. The committee is continuing to establish a body of work so they may be considered as a commission. Dr. Love also mentioned that each received an invitation from Liz Lennon for subcommittee engagement for planning purposes with the goal of every subcommittee feeling invested. She reminded everyone to please make sure that as a member you accept the invitation. Please submit your reports due to this being a way for other committees to remain informed about each committee and its activities. If you're having issues with your reports please let us know.

Dr. Love also mentioned the developing planning which has two phases which are the departmental plan and planning through retreats. This year we have presented an all-call and that is inviting chairs and subchairs to discuss planning that will fit their needs. She also mentioned providing written reports from staff starting in March and will insert them into the monthly reminder before the meeting so that you may see what staff is presenting. Lastly, the presentation on the quarterly meeting options for commissions and boards moving forward,

Quarterly meeting options;

1. All boards and commissions attend one quarterly meeting in person as a collective in place of the regularly scheduled virtual monthly meeting (no individual body meeting).



- 2. All boards and commissions attend one meeting in person AND one virtually within the same month on a quarterly basis (just two meetings in one month).
- 3. All boards and commissions meet in person in **their individual monthly meetings** once per quarter (one meeting).

Dr. Love then proceeded to open the floor for questions and comments regarding the quarterly meeting presentation.

Committee member Chuck Byrd mentioned that he would like to select the one that has fewer meeting dates.

Chair Black mentioned she was in favor of the third option and desires to gather for a more collaborative effort.

Dr. Love also reiterated that for those who opt-out and are not able to meet to send an ambassador as a representation so that information will not be missed.

Professor Kuo discussed how youth could possibly be involved through contact with school resource officers and could possibly have a subsection on the survey to address questions for them.

Dr. Love shared that the survey is going out to everyone meaning different ethnicities however due to ACAAD holding the survey proceeded to ask Professor Kuo how important it is even though we're focusing on one population how important it is to address others as well. Professor Kuo mentioned it is important to include different demographics so that it may capture all points of view so that it may be a comparison.



Dr. Love also asked Professor Kuo how important the timeline is to be extended. Professor Kuo shared that it's important so that a double-check can be done and you can add different elements such as focus groups so that we may create solid questions from people who are a part of the population we're surveying.

Committee members Chuck Byrd and Commissioner Sue Polinsky asked questions regarding online surveys and the estimated time it will take for individuals to take the survey.

Chair Black mentioned Jodie Stanley will be responsible for the marketing aspect of it and thanked Professor Kuo for attending and asked for him to give final remarks.

Dr. Love also asked members to make sure names are being inputted in the chat due to the recordings not displaying names and being difficult for the staff to retrieve for attendance.
