



**Greensboro Criminal Justice Advisory Commission**  
**Meeting Minutes**

**Executive Board Updates**

### **Police Reporting System**

It was discussed previously that you could go online, put in your case number and retrieve the report and print with no fee. The commission having the admin go through the process of trying to retrieve a report with the details of the findings in our next meeting and discussed a recommendation to have the process reviewed by a person in GPD.
